

RESOLUTION NO. 2000-44

AUTHORIZING AN INCREASE TO CONTRACT NO. 97156 WITH WHITLEY & WHITLEY INC. TO PROVIDE ADDITIONAL ARCHITECTURAL AND ENGINEERING SERVICES FOR PROJECT 7.55, TOWER CITY STATION PLATFORM AND COLUMN BASES RESTORATION IN THE AMOUNT OF \$4,560.00 FOR A TOTAL CONTRACT AMOUNT OF \$26,975.00-(RTA DEVELOPMENT FUND-100% LOCAL FUNDS, PROJECT DEVELOPMENT & ENGINEERING DEPARTMENT BUDGET)

WHEREAS, pursuant to the General Manager's delegated Small Purchase authority, an agreement was entered into with Whitley and Whitley, Inc., 20600 Chagrin Boulevard, Shaker Heights, Ohio 44112 to provide architectural and engineering services for Project 7.55, Tower City Station Platform and Column Bases Restoration in the amount of \$15,000.00; and

WHEREAS, additional change order work was authorized in the amount of \$7,415.00 and added to the price of the small purchase, thereby increasing the cost to \$22,415.00; and

WHEREAS, additional work for the design of emergency lighting is necessary that will result in an increase of \$4,560.00 and will extend the price of the agreement beyond the small purchase limit delegated to the General Manager; and

WHEREAS, the General Manager has deemed the offer of Whitley & Whitley Inc., as negotiated, to perform said additional work at a cost of \$4,560.00 to be in the best interest of the Authority.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the price of Small Purchase Agreement No. 97156 with Whitley and Whitley, Inc., including changes approved by the General Manager's delegated Small Purchase Authority, is hereby recognized as twenty two thousand four hundred fifteen and 00/100 dollars (\$22,415.00).

Section 2. That the additional change order in the amount of four thousand five hundred sixty and 00/100 dollars (\$4,560.00), as accepted be authorized for a total revised contract price of twenty six thousand nine hundred seventy five and 00/100 dollars (\$26,975.00).

Section 3. That all other terms and conditions of said contract shall remain unchanged.


Section 4. That said contract shall be payable out of RTA Development Fund-100% Local Funds, Project Development & Engineering Budget.
