

RESOLUTION NO. 2001 -60

AUTHORIZING CONTRACT 2001-001 WITH PROVIDE A RIDE FOR VANPOOL OPERATION FOR A THREE YEAR PERIOD WITH TWO ADDITIONAL ONE YEAR OPTIONS AT A PRICE NOT TO EXCEED \$3,614,389.00 FOR THE BASE THREE YEARS (GENERAL FUND – OPERATIONS PLANNING DEPARTMENT BUDGET)

WHEREAS, the Greater Cleveland Regional Transit Authority has determined the need to obtain the services of a professional transportation provider to supply quality and efficient transportation services to clients who are transitioning from welfare to work; and

WHEREAS, the offer of Provide A Ride located at 4299 Cranwood Parkway, Cleveland, Ohio 44128 for the operation of the GCRTA Vanpool Program for a period of three years, with two additional one year options was received on February 20, 2001; and

WHEREAS, Provide A Ride has offered to perform said work for the base three years at a total negotiated price not to exceed three million, six hundred fourteen thousand, three hundred eighty nine & 00/100 dollars (\$3,614,389.00), based on a combination of hourly and mileage rates which are applied to actual data; and

WHEREAS, Provide A Ride has offered to perform said work for the option years at a total negotiated price not to exceed one million, two hundred ninety two thousand, one hundred seventy nine & 00/100 dollars (\$1,292,179.00) for Option Year 1 and, one million, three hundred thirty five thousand, nine hundred ninety one & 00/100 dollars (\$1,335,991.00) for Option Year 2, based on a combination of agreed upon hourly and mileage rates; and

WHEREAS, the General Manager deems the offer of Provide A Ride to be advantageous to the Authority and recommends acceptance by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of Provide A Ride for the operation of the GCRTA Vanpool Program for a period of three years, with two one year options, be and the same is hereby accepted as being in the best interest of the Authority.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Provide A Ride for the operation of the GCRTA Vanpool Program, for a period of three years, with the right to exercise two additional one year options at the negotiated not to exceed amounts specified.

Section 3. That said contract shall be payable out of the RTA General Fund, Operations Planning Department Budget, at a price not to exceed three million, six hundred fourteen thousand, three hundred eighty nine & 00/100 dollars (\$3,614, 890.00) for the base three years, based on a combination of agreed upon hourly and mileage rates.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon appropriation for the current and future contract years and upon compliance by the contractor to the Specification and Addenda, if any: the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2000-065; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
