

RESOLUTION NO. 2001-155

AUTHORIZING CONTRACT NO. 2001-132-A WITH APEX CONSTRUCTION & MANAGEMENT CO., INC. TO PROVIDE GENERAL TRADES SERVICES FOR THE MODIFICATIONS FOR EXISTING INTEGRATED COMMUNICATION CENTER IN THE AMOUNT OF \$276,490.00 (RTA DEVELOPMENT FUND, PROJECT DEVELOPMENT AND ENGINEERING DEPARTMENT BUDGET)

WHEREAS, General Trades services are necessary for construction of the new Integrated Communication Center; and

WHEREAS, the bid of Apex Construction & Management Co., Inc., 5261 Clement Street, Maple Heights, Ohio 44137, for General Trades services for Project 44B, Integrated Communication Center was received on November 7, 2001, in the amount of \$276,490.00; and

WHEREAS, the General Manager deems the bid of Apex Construction & Management Co., Inc. to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Apex Construction & Management Co., Inc. for General Trades services for Project 44B, Integrated Communication Center be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Apex Construction & Management Co., for General Trades services for Project 44B, Integrated Communication Center.


Section 3. That said contract shall be payable in the amount of two hundred seventy six thousand four hundred ninety and 00/100 dollars (\$276,490.00) payable out of the RTA Development Fund, including but not limited to, Capital Grant OH-90X306 (\$221,192.00 in Federal Funds, which represents 80% of the total cost).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor with the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2001-064; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution is contingent upon compliance by the Contractor, prior to execution of the contract, with all requirements of the solicitation regarding eligibility for award.


Section 6. That this resolution shall become effective immediately upon its adoption.
