

RESOLUTION 2001-160

AUTHORIZING CONTRACT NO. 2001-111 WITH GE TRANSPORTATION SYSTEMS FOR THE FURNISHING OF FOUR LINE BREAKER ASSEMBLIES AS SPECIFIED FOR AN AMOUNT OF \$31,200.00 (RTA DEVELOPMENT FUND - RAIL DEPARTMENT BUDGET).

WHEREAS, the bid of GE Transportation Systems located at 2901 East Lake Road, Erie, PA 16531 for the furnishing of four line breakers was received on October 11, 2001 for the unit prices set forth in said bid, involving an expenditure of thirty one thousand two hundred & 00/100 dollars (\$31,200.00); and

WHEREAS, said bid was the only responsive bid received in response to the solicitation; and

WHEREAS, In accordance with Ohio Revised Code Section 306.43 (B), when fewer than two responsive bids are received, a regional transit authority may negotiate a price with the sole responsive bid or may rescind the solicitation and re-procure the item; and

WHEREAS, negotiations resulted in acceptance of the bid price of thirty one thousand two hundred & 00/100 dollars (\$31,200.00) which was determined to be fair and reasonable to the Authority; and

WHEREAS, the General Manager deems the bid of GE Transportation Systems to be a responsive bid from a responsible bidder and in the best interest of the Authority and recommends acceptance thereof by the Board of Trustees.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of GE Transportation Systems for the furnishing of four line breakers for a price of thirty one thousand two hundred & 00/100 dollars (\$31,200.00) be and the same is hereby accepted as a responsive bid from a responsible bidder.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with GE Transportation Systems for the furnishing of four line breakers as specified.

Section 3. That said contract in the amount of thirty one thousand two hundred & 00/100 dollars (\$31,200.00) shall be payable from the RTA Development Fund including but not limited to, Capital Grant OH-03-0186 (\$24,960.00 in Federal Funds, which represents 80% of the total cost).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, if any: the Affirmative Action Plan adopted by the Board of Trustees in resolution 2001-054: bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
