

RESOLUTION NO. 2001- 166

AUTHORIZING CONTRACT NO. 2001-129 WITH SAFETYLANE EQUIPMENT CORPORATION FOR REPLACEMENT OF CHASSIS/BUS WASH LIFT AT CENTRAL BUS MAINTENANCE FACILITY, IN THE AMOUNT OF \$97,248.00 - RTA CAPITAL FUND (PROJECT DEVELOPMENT & ENGINEERING DEPARTMENT BUDGET)

WHEREAS, a new chassis/bus wash lift at Central Bus Maintenance Facility is required to replace the present inoperative unit; and

WHEREAS, the bid of Safetylane Equipment Corporation, with offices at 115 N. College Avenue, Bloomington, IN 47404 for Project 9.39, Replacement of Chassis/Bus Wash Lift at Central Bus Maintenance Facility was received on November 7, 2001, at a price of \$97,248.00 and

WHEREAS, the bid of Safetylane Equipment Corporation was the sole bid received; and

WHEREAS, in accordance with Ohio Revised Code Section 306.43(B), when fewer than two responsive bids are received, a regional transit authority may negotiate a price with the sole responsive bid or may rescind the solicitation and re-procure the item; and

WHEREAS, negotiations resulted in acceptance of the bid price of ninety seven thousand two hundred forty eight & 00/100 dollars (\$97,248.00) which was determined to be fair and reasonable to the Authority; and

WHEREAS, the General Manager deems the bid of Safetylane Equipment Corp. to be a responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Safetylane Equipment Corp. for Project 9.39, Replacement of Chassis/Bus Wash Lift at Central Bus Maintenance Facility be and the same is hereby accepted as a responsive bid from a responsible bidder.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Safetylane Equipment Corp. for Project 9.39, Replacement Chassis/Bus Wash Lift at Central Bus Maintenance Facility.

Section 3. That said contract shall be payable out of the RTA Capital Fund, Project Development and Engineering Department Budget, in the amount of ninety seven thousand two hundred forty eight and 00/100 dollars (\$97,248.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2001-064; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.


Section 5. That this resolution shall become effective immediately upon its adoption.
