

RESOLUTION NO. 2001-173

AUTHORIZING CONTRACT NO. 2001-127A THROUGH 2001-127D WITH METAL MANAGEMENT, INC., ADELMAN'S TRUCK PARTS CORPORATION, MIDWEST BUS CORPORATION, AND JAMES L. WOODS FOR THE SALE OF FIFTY-ONE USED TRANSIT VEHICLES IN "AS IS" CONDITION FOR A TOTAL SALE PRICE OF FIFTEEN THOUSAND NINE HUNDRED FOUR AND 65/100 DOLLARS (\$15,904.65).

WHEREAS, fifty-one (51) transit buses have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, the bids of three companies and one individual for said vehicles were received on the 6<sup>th</sup> day of November, 2001; and

WHEREAS, the General Manager deems the bids of Metal Management, Inc., Adelman's Truck Parts Corporation, Midwest Bus Corporation, and James L. Woods to be the highest responsive bids from responsible bidders for the items identified in said Attachment A hereto and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Metal Management, Inc., whose address is 254 Doremus Avenue, Newark, New Jersey, 07105, for the purchase of twenty-nine (29) vehicles as listed on Attachment A hereto for a total purchase price of five thousand four hundred forty-five & 00/100 dollars (\$5,445.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 2. That the bid of Adelman's Truck Parts Corporation, whose address is 2000 Waynesburg Road, S.E., Canton, Ohio, 44707 for the purchase of twelve (12) vehicles as listed on Attachment A hereto for a total purchase price of three thousand & 00/100 dollars (\$3,000.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 3. That the bid of Midwest Bus Corporation, whose address is 1940 West Stewart Street, Owosso, Michigan, 48867 for the purchase of six (6) vehicles as listed on Attachment A hereto for a total purchase price of six thousand & 00/100 dollars (\$6,000.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.


Section 4. That the bid of James L. Woods, whose address is 8408 Cook Yankeetown Road, Mount Sterling, Ohio 43143 for the purchase of four (4) vehicles as listed on Attachment A hereto for a total purchase price of one thousand four hundred fifty-nine & 65/100 dollars (\$1,459.65) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 5. That the General Manager of the Authority be and he is hereby authorized to enter into a contracts with Metal Management, Inc., Adelman's Truck Parts Corporation, and James L. Woods for the vehicles identified on Attachment A hereto on such terms as are in the best interest of the Authority.


