RESCINDING APPROVAL OF RESOLUTION 2001-130 FOR CONTRACT NO. 2001-067A WITH CONCENTRA MEDICAL CENTERS FOR THE FURNISHING OF SPECIMEN COLLECTION SERVICES FOR A PERIOD OF THREE YEARS WITH AN OPTION FOR ONE ADDITIONAL YEAR.

WHEREAS, the award of Contract No. 2001-067A to Concentra Medical Centers located at 5500 South Marginal Road, Cleveland, Ohio 44103 for the furnishing of specimen collection services was adopted by Resolution 2001-130 on September 18, 2001; and

WHEREAS, Concentra Medical Centers has refused to execute the Authority's form of contract without changes unacceptable to the Authority; and


WHEREAS, as a result, the General Manager deems it in the best interest of the Authority to rescind award of Contract No. 2001-067A.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That Resolution No. 2001-130, authorizing the award of a contract to Concentra Medical Centers for the furnishing of specimen collection services is hereby rescinded.

Section 2. That this resolution shall become effective immediately upon its adoption.



- 1.0 **PURPOSE/SCOPE:** This action will allow the Authority to rescind resolution 2001-130 for the authorization of furnishing specimen collection services for a period of three years with an option for one additional year.
- 2.0 **DESCRIPTION/JUSTIFICATION:** After approval and contract preparation it was found that Concentra Medical Centers would not agree to execute the Authority's form of contract without unacceptable changes.
- 3.0 **PROCUREMENT BACKGROUND:** Upon contract preparation, Concentra Medical Centers refused to execute the Authority's form of contract without several modifications. These changes were deemed unacceptable by the Authority's Legal and Procurement departments and it was agreed that it would be in the best interest of the Authority to rescind the award. Because this was a divisible procurement, the Authority can continue to screen applicants and employees for random drug testing with St. Vincent's Charity Hospital. Upon approval by the Board of Trustees by separate resolution, an additional screening contract with MetroHealth Medical will be executed, which will provide a convenient location for the West Side.
- 4.0 **POLICY IMPACT:** None
- 5.0 **ECONOMIC IMPACT:** None
- 6.0 **ALTERNATIVES:** Reject the rescision. Rejection of this request would cause the Authority to continue to have funds encumbered which could not be expended due to the lack of an executed contract.
- 7.0 **RECOMMENDATION:** It is recommended that this request for rescinding of resolution is honored and the resolution is passed authorizing the General Manager to proceed to rescind resolution 2001-130.
