AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT WITH WOOD COUNTY PARK DISTRICT FOR THE TRANSFER OF SIX (6) OBSOLETE 1997 STARTRAN PARATRANSIT VEHICLES

WHEREAS, the Wood County Park District has requested that the Greater Cleveland Regional Transit Authority transfer six (6) obsolete Paratransit vehicles to meet their current service level requirements; and

WHEREAS, pursuant to Ohio Revised Code Section 306.43(L) (4), the disposition of property by a regional transit authority to a department of the federal or state government, to a political subdivision of the state, or to any governmental entity is exempt from the competitive procurement process; and

WHEREAS, the Wood County Park District is a political subdivision of the State of Ohio; and

WHEREAS, the six (6) vehicles have exceeded their useful life and are scheduled for disposition by the Greater Cleveland Regional Transit Authority; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the authority is hereby authorized to transfer title of ownership of the six (6) vehicles to the Wood County Park District, on such terms and conditions as he deems appropriate to protect the Authority's interests.

Section 2. That this resolution shall become effective immediately upon its

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to transfer six (6) obsolete 1997 Startran Paratransit vehicles as listed on Attachment "A" in an "As Is / Where Is" condition.
- 2.0 DESCRIPTION/JUSTIFICATION: These six (6) vehicles have exceeded their useful life of five (5) years and are scheduled to be disposed of through retirement or sale as scrap. It is recommended that these vehicles be transferred to help the Wood County Park District meet their needs.
- 3.0 PROCUREMENT BACKGROUND: The transfer of material or equipment to other public entities is an approved method of asset disposition. Pursuant to Sec. 306.43(L) (4), the disposition of property by a regional transit authority to a department of the federal or state government, to a political subdivision of the state, or to any other governmental entity is exempt from the competitive procurement process.

The Authority acquired these vehicles for temporary use and to supplement the Authority's own Elf buses. These vehicles were acquired from Laketran through a similar disposal process. The title transfer of these vehicles to Wood County Park District has the concurrence of Laketran.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: The Office of Business Development does not perform Affirmative Action reviews or establish goals on asset transfers conducted through an intergovernmental agreement.
- 5.0 POLICY IMPACT: This disposal is consistent with the Greater Cleveland Regional Transit Authority's vehicle replacement policy.
- 6.0 ECONOMIC IMPACT: No money will be generated from this action, nor will there be an expenditure of funds. The Wood County Park District will pay for all costs incurred with this transaction. Previous scrap sales of Paratransit vehicles have resulted in a nominal return to the Authority.

- 7.0 ALTERNATIVES: <u>Reject this offer</u>. Dispose of the vehicles by an alternative method such as sealed bids, or through our auction process.
- 8.0 RECOMMENDATION: It is recommended that the asset transfer of six (6) StarTran paratransit vehicles be made to the Wood County Park District be accepted and the resolution passed authorizing the General Manager to execute the transfer.
- 9.0 ATTACHMENTS: Attachment "A" listing of vehicles.
