- 1.0 PURPOSE/SCOPE: This resolution will allow the Authority to enter into a contract with Atlantic Track & Turnout Co. for the furnishing of 39.00 tons of 100# RB rail.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority utilizes the new rail for the replacement of worn and/or damaged sections and as part of its Track Rehabilitation Overhaul Program.
- 3.0 PROCUREMENT BACKGROUND: Invitations for bid were sent to ten prospective bidders. This is a divisible procurement, and a separate award is recommended for 115# rail, turnouts, and other hardware. Three responses were received. - 6.0 ECONOMIC IMPACT: This procurement will be funded through the RTA Development Fund including but not limited to Capital Grant OH-90-X387, line item (\$25,708.80 in Federal Funds, which represents 80% of the total cost), Rail District Department budget in an amount of thirty two thousand one hundred thirty six and 00/100 dollars (\$32,136.00). The total estimate for all items included in this solicitation was \$180,000.00. The total award amount of \$66,371.00 is approximately 63% below the estimate.
