RESCINDING APPROVAL OF RESOLUTION 2002-029 FOR CONTRACT NO. 2001-154 WITH SOLUTIONS CONSULTING LLC FOR THE IMPLEMENTATION OF THE ORACLE HUMAN RESOURCE MANAGEMENT SYSTEM FOR AN AMOUNT NOT TO EXCEED \$366,080 (RTA DEVELOPMENT FUND, INFORMATION SYSTEMS DEPARTMENT BUDGET).

WHEREAS, the award of Contract No. 2001-154 to Solutions Consulting, LLC located at 5151 Pfeifer Road, Cincinnati, Ohio 45242 to assist the Greater Cleveland Regional Transit Authority in the design, development, and implementation of the Oracle Human Resource Management System was adopted by Resolution 2002-029 on February 19, 2002; and

WHEREAS, Solutions Consulting, LLC has refused to execute the Authority's form of contract without changes unacceptable to the Authority; and

WHEREAS, as a result, the General Manager deems it in the best interest of the Authority to rescind award of Contract No. 2001-154.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That Resolution No. 2002-029, authorizing the award of a contract to Solutions Consulting, LLC to provide Oracle Software implementation assistance is hereby rescinded.

Section 2. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to rescind Resolution 2002-029 to provide Oracle Software implementation assistance.
- 2.0 DESCRIPTION/JUSTIFICATION: After approval and contract preparation it was found that Solutions Consulting, LLC would not agree to execute the Authority's form of contract without unacceptable changes.
- 3.0 PROCUREMENT BACKGROUND: Upon contract preparation, Solutions Consulting, LLC refused to execute the Authority's form of contract without several modifications. These changes were deemed unacceptable by the Authority's Legal and Procurement departments and it was agreed that it would be in the best interest of the Authority to rescind the award.
- 4.0 DBE/ AFFIRMATIVE ACTION BACKGROUND: None
- 5.0 POLICY IMPACT: None
- 6.0 ECONOMIC IMPACT: Recension of this contract with Solutions Consulting will result in the Authority utilizing another vendor which will cost an additional \$ 167,920.00.
- 7.0 ALTERNATIVES: Reject the rescision. Rejection of this request would cause the Authority to be unable to award the contract for these services to another vendor to assist in this important and time sensitive HRMS system.
