AUTHORIZING CONTRACT 2002-075 WITH AUTO DIESEL ELECTRIC, INC., FOR THE FURNISHING OF NIEHOFF GENERATOR PARTS AS SPECIFIED AND AS REQUIRED FOR A PERIOD OF ONE YEAR IN AN AMOUNT NOT TO EXCEED \$112,086.66 (GENERAL FUND, FLEET MANAGEMENT DEPARTMENT BUDGET).

WHEREAS, the Authority has recurring requirements to purchase Niehoff Generator parts as specified to repair electrical system on Authority buses; and

WHEREAS, the bid of Auto Diesel Electric, Inc., located at 410 East 6th Street, Reno, Nevada 89512, for Niehoff Generator parts as specified and as required for a period of one (1) year was received on June 20, 2002, in an amount not to exceed \$112,086.66; and

WHEREAS, the General Manager deems the bid of Auto Diesel Electric, Inc., to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Auto Diesel Electric, Inc., for Niehoff Generator parts as specified and required for a period of one (1) year be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Auto Diesel Electric, Inc., for Niehoff Generator parts as specified and as required for a period of one year.

Section 3. That said contract shall be payable from the General Fund, Fleet Department Budget, in an amount not to exceed one hundred twelve thousand eighty-six & 66/100 dollars (\$112,086.66).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor with the Specifications and Addenda thereto, if any, the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2002-120 bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to enter into a contract with Auto Diesel Electric, Inc., for Niehoff Generator parts as specified.
- 2.0 DESCRIPTION/JUSTIFICATION: Niehoff generators are used on the Authority's Cummins bus engines. These generators are rebuilt by the personnel in the Authority's unit rebuild section located at Central Bus Maintenance Facility (CBMF).
- 3.0 PROCUREMENT BACKGROUND: Bid packages were sent to fourteen prospective bidders and seven bids were received on June 20. The unit prices for each bid are outlined in Attachment A.

This is a divisible bid with 11 line items. Of the six bids received Auto Diesel Electric, Inc. is the apparent low bidder on ten of the 11 line items. Attachment A shows that other bidders bid lower unit prices on a few line items than those in Auto Diesel 's bid; however, these prices were from bidders that were determined non-responsive or technically non-compliant. The remaining item will be purchased through small purchase quotes. A price analysis was conducted by the Procurement Department and the ten unit prices totaling \$112,086.66 bid by Auto Diesel are considered fair and reasonable to the Authority

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative requirements have been met. A 0% DBE goal was established for this procurement due to the lack of subcontracting opportunities.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This contract shall be payable from the General Fund, Fleet Management Department budget. The bid price of \$112,086.66 is 9.6% above the \$101,279.00 estimate for this purchase.
- 7.0 ALTERNATIVES: Reject all bids. Rejection of this bid will delay the rebuilding of Niehoff Generators in the transit coaches which may impact the service goals of the Authority.

- 8.0 RECOMMENDATION: It is recommended that the bid of Auto Diesel Electric, Inc., be accepted and the resolution passed authorizing the General Manager to enter into a contract.
