

RESOLUTION 2002- 155

AUTHORIZING CONTRACT NO. 2002-112 WITH BUCKEYE POWER SALES CO., INC. FOR THE FURNISHING OF ONE 200 KW EMERGENCY GENERATOR SET AS SPECIFIED AT A PRICE OF \$52,983.00 (RTA CAPITAL FUND, PROJECT DEVELOPMENT AND ENGINEERING DEPARTMENT BUDGET)

WHEREAS, the bid of Buckeye Power Sales Co., Inc. located at 8465 Tower Drive, Twinsburg, OH 44087-0394 for the furnishing of one 200 KW emergency generator set, as specified was received on September 10, 2002, at a price of fifty two thousand nine hundred eighty three & 00/100 dollars (\$52,983.00); and

WHEREAS, the General Manager deems the bid of Buckeye Power Sales Co., Inc. to be lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Buckeye Power Sales Co., Inc. received on September 10, 2002 be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Buckeye Power Sales Co., Inc. for the furnishing one 200 KW emergency generator set as specified.

Section 3. That said contract shall be payable from the RTA Capital Fund, Project Development and Engineering Department Budget, in an amount not to exceed fifty-two thousand nine hundred eighty three & 00/100 dollars (\$52,983.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, if any the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2002-120: bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to enter into a contract for the furnishing of one 200 KW emergency generator set (Kohler) as specified.
- 2.0 DESCRIPTION/JUSTIFICATION: This emergency generator is required as a backup power feeder for the Hayden Garage as we have found that the current CEI backup feeder is unreliable and a more secure backup unit is required for the Authority's needs. The generator will power the electrical system and other accessories as required during power outages that may occur to keep the facility operational. This unit will also serve the Windermere station in emergencies.
- 3.0 PROCUREMENT BACKGROUND: Invitations for bid were sent to eight (8) prospective bidders. Bids were opened on September 10, 2002. There were two (2) bids submitted for this procurement. Summary of the two (2) responsive bids are as follows :



The bid of Buckeye Power Sales Co., Inc. has been determined by the Procurement Department to be a responsive bid from a responsible bidder. A price analysis has been performed and the Procurement Department has determined the price to be fair and reasonable to the Authority.

- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of subcontracting opportunities
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the RTA Capital Fund, Project Development and Engineering Department Budgets, in the amount of fifty two thousand nine hundred eighty three & 00/100 dollars (\$52,983.00) The bid price is twenty four percent (24%) below the \$70,000.00 estimated cost for this procurement.
- 7.0 ALTERNATIVES: Reject all bids. Rejection of this award would delay procurement of this product and cause the Authority to be without reliable emergency backup power for the Hayden and Windermere facilities.
- 8.0 RECOMMENDATION: It is recommended that the bid of Buckeye Power Sales Co., Inc. be accepted and the resolution passed authorizing the General Manager to enter into a contract.
