AUTHORIZING CONTRACT 2002-114B WITH HANS TRUCK & TRAILER REPAIR INC., dba HANS FREIGHTLINER OF CLEVELAND OHIO FOR THE FURNISHING OF DETROIT DIESEL SERIES 50 CNG AND DIESEL ENGINE PARTS AS SPECIFIED AND AS REQUIRED FOR A PERIOD OF ONE YEAR IN AN AMOUNT NOT TO EXCEED \$105,421.35 (GENERAL FUND – FLEET MANAGEMENT DEPARTMENT BUDGET)

WHEREAS, the Authority has a recurring need for various parts to maintain requirement to maintenance the fleets Detroit Diesel Series 50 CNG and diesel engines; and

WHEREAS, the bid of Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio, located at 14520 Broadway Avenue, Cleveland, OH 44125 for furnishing Detroit Diesel Series 50 CNG and diesel engine parts, as specified and as required, for a period of one (1) year was received on October 15, 2002, in a total amount not to exceed one hundred five thousand four hundred twenty-one and 35/100 dollars (\$105,421.35); and

WHEREAS, the General Manager deems the bid of Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

- Section 1. That the offer of Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio for furnishing Detroit Diesel Series 50 CNG and diesel engine parts, as specified and as required and as defined in Attachment A, for a period of one year, be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.
- Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio, for furnishing Detroit Diesel Series 50 CNG and diesel engine parts, as specified and as required, for a period of one (1) year.
- Section 3. That said contract shall be payable from the General Fund, Fleet Management Department Budget in the amount not to exceed one hundred five thousand four hundred twenty-one and 35/100 dollars (\$105,421.35) and
- Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2002-120; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

- 1.0 PURPOSE: This action will allow the Authority to enter into a contract for obtaining Detroit Diesel Series 50 CNG and diesel engine parts as specified, and as required, for a period of one year.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority has a recurring need to repair and or replace worn engine parts in its 145 CNG and 45 diesel powered Detroit Diesel Series 50 CNG and diesel engines.

PROCUREMENT BACKGROUND: Invitations for Bids were sent to six (6) potential bidders, and four bids were received. Bids were opened on October 15, 2002. This (IFB) was divisible containing 22 line items. Bid prices are summarized on Attachment A. Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio, was the successful bidder on 3 of those line items.

The offer of Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio has been determined by the Procurement Department to be the lowest responsive bid from a responsible offeror.

A cost/price analysis has been performed and the Procurement Department had determined the price to be fair and reasonable to the Authority.

- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to insufficient subcontracting opportunity.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This contract shall be funded through the RTA General Fund, Fleet Management Department Budget, at a total price not to exceed one hundred five thousand four hundred twenty-one and 35/100 dollars (\$105,421.35)
- 7.0 ALTERNATIVES: Rejection of the offer of Hans Truck & Trailer Repair Inc., dba Hans Freightliner of Cleveland Ohio would leave the Authority without replacement engine parts for the Detroit Diesel Series 50 CNG and diesel engines.
