

RESOLUTION NO. 2002-193

AUTHORIZING CONTRACT NO. 2002-132B WITH ADELMAN'S TRUCK PARTS CORP./LARRY ADELMAN FOR THE SALE OF FIVE USED TRANSIT VEHICLES AND FIVE PIECES OF MISCELLANEOUS EQUIPMENT IN "AS IS" CONDITION FOR A TOTAL SALE PRICE OF \$7,890.00.

WHEREAS, five transit vehicles and five pieces of miscellaneous equipment have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, the Ohio Revised Code, Section 306.43(k) provides that a regional transit authority shall make a sale or other disposition of property through full and open competition; and

WHEREAS, the bid of Adelman's Truck Parts Corp./Larry Adelman, 2000 Waynesburg Road, S.E. Canton, OH 44707 was received on the 25th day of November, 2002; and

WHEREAS, the General Manager deems the bids of Adelman's Truck Parts Corp./Larry Adelman, to be the highest responsive bid from a responsible bidder for the items identified in said Attachment A hereto and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Adelman's Truck Parts Corp./Larry Adelman, 2000 Waynesburg Road, S.E. Canton, OH 44707 for the purchase of five transit vehicles and five pieces of miscellaneous equipment, as identified, on Attachment A hereto for a total bid price of seven thousand eight hundred ninety & 00/100 dollars (\$7,890.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.



That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Adelman's Truck Parts Corp./Larry Adelman for the sale of five transit vehicles and five pieces of miscellaneous equipment as identified on Attachment A hereto on terms which are in the best interest of the Authority.

Section 3. That proceeds of said sale in the amount of seven thousand eight hundred ninety & 00/100 dollars (\$7,890.00) shall be deposited into the General Fund.


Section 4. That this resolution shall become effective immediately upon its adoption.


- 1.0 PURPOSE: This action will allow the Authority to enter into a contract for the sale of five used transit vehicles and five pieces of miscellaneous equipment outlined in Attachment A.
- 2.0 DESCRIPTION/JUSTIFICATION: The transit vehicles and tow motors, as identified in Attachment A to the resolution have exceeded the useful life criteria established by the Authority's Vehicle Replacement Policy and FTA regulations. The equipment has deteriorated to such a degree that the cost to return them to a safe and reliable condition would far exceed their value. It was recommended that the vehicles and tow motors not be repaired, but sold on an "as is" basis. Ohio Revised Code, Section 306.43(k) authorizes the sale and disposition of property through full and open competition.
- 3.0 PROCUREMENT BACKGROUND: Bid packages for the sale of sixty-one (61) vehicles and 5 tow motors were sent to 31 companies and/or individuals. The solicitation for the sale of the sixty-one transit vehicles was advertised in two local papers of general circulation, posted on the GCRTA web site and posted on the nationally known transit web site (ibus.com). The bid of Adelman's Truck Parts Corp/Larry Adelman was received by 2:00 p.m. on November 25, 2002. The bids are as listed on Attachment A. Adelman's Truck Parts Corp/Larry Adelman bid of seven thousand eight hundred ninety & 00/100 dollars for 5 vehicles and 5 tow motors designated as scrap, is considered fair and reasonable. It is in the best interest of the Authority to accept the bid of Adelman's Truck Parts Corp/Larry Adelman, Inc.
- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: Does Not Apply.
- 5.0 POLICY IMPACT: This disposal is consistent with the Greater Cleveland Regional Transit Authority's Vehicle Replacement Policy and the Procurement Policy regarding the sale or disposal of property.
- 6.0 ECONOMIC IMPACT: The monies from this sale will be deposited into the General Fund.
- 7.0 ALTERNATIVES: Reject all bids. Rejection of all bids will delay the sale of these used transit vehicles and tow motors and cause the Authority to incur additional costs for storage.
- 8.0 RECOMMENDATION: It is recommended that the bid of Adelman's Truck Parts Corp/Larry Adelman be accepted and the resolution passed authorizing the General Manager to enter into a contract.
- 9.0 ATTACHMENTS: None.

Recommended and certified as appropriate to the availability of funds, legal form and conformance with the Procurement requirements.

- 6.0 ECONOMIC IMPACT: This procurement shall be payable from the RTA Capital Fund, Project Development & Engineering Department budget.
- 7.0 ALTERNATIVES: Reject this amendment. Rejection of this amendment would delay the obtaining a "No Further Action" (NFA) status from the Bureau of Underground Storage Tank Regulations (BUSTR), and risk environmental penalties.
- 8.0 RECOMMENDATION: It is recommended that the contract increase be accepted and the resolution passed authorizing the General Manager to amend the contract.
