

RESOLUTION NO. 2003 - 057

AUTHORIZING CONTRACT 2003-007 WITH REPUBLIC WASTE SERVICES FOR THE FURNISHING OF RUBBISH/TRASH REMOVAL FROM THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY FACILITIES, AS REQUIRED AND SPECIFIED, FOR A THREE (3) YEAR PERIOD IN AN AMOUNT NOT TO EXCEED \$264,345.00 (GENERAL FUND, SERVICE MANAGEMENT DEPARTMENT BUDGET).

WHEREAS, the Greater Cleveland Regional Transit Authority has a recurring need for rubbish/trash removal service; and

WHEREAS, the bid of Republic Waste Services located at 3980 Jennings Road, Cleveland, Ohio 44109 for the furnishing of rubbish/trash removal services for a three year period was received on April 8, 2003 for a price set forth in said bid not to exceed two hundred sixty four thousand three hundred forty five & 00/100 dollars (\$264,345.00); and

WHEREAS, the General Manager deems the bid of Republic Waste Services to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Republic Waste Services received on April 8, 2003 be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.


Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Republic Waste Services for the furnishing of rubbish/trash removal service from the Greater Cleveland Regional Transit Authority facilities as required for a period of three (3) years.

Section 3. That said contract shall be paid out of the General Fund, (Service Management Department Budget), in an amount not to exceed two hundred sixty four thousand three hundred forty five & 00/100 dollars (\$264,345.00)

Section 4. That said contract shall be binding upon and an obligation of the Authority, contingent upon appropriation of funds for future years; contingent upon compliance by the contractor to the Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2002-120; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This resolution will allow the Authority to enter into a contract for rubbish/trash pickup at all the Authority's locations for a period of three (3) years.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority contracts for regularly scheduled collection of rubbish/trash from all of its facilities. The contractor provides regular and non-routine pickup. GCRTA has historically contracted for the collection and disposal of rubbish and trash.
- 3.0 PROCUREMENT BACKGROUND: Solicitation packages were requested by twelve (12) potential bidders. Three responses were received with two responsive bids being opened on April 8, 2003 with the following results:

The bid of Republic Waste Services has been determined by the Procurement Department to be the lowest responsive bid from a responsible bidder.


A price analysis was performed on the bid of Republic Waste Services and the Procurement Department has determined the bid to be fair and reasonable. Prices have remained the same or have been lowered from the bid price in 2001 from the previous vendor.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 7% DBE goal was established for this procurement. Republic Waste Services has committed to achieve the goal through the utilization of the following DBE firm(s):

- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the General Fund, Service Management Department budget, in an amount not to exceed two hundred sixty four thousand three hundred forty five & 00/00 (\$264,345.00). The estimate for this service is \$84,000.00 per year. The bid price is 4.9% above the estimate. The expenditure is based on an estimated number of pickups for large containers of one every four weeks. The expenditure may be reduced if pick up of large containers is not required at that interval.
- 7.0 ALTERNATIVES: Reject this offer. Rejection of this offer would delay procurement of this service and risk not having rubbish/trash removal service available to meet the needs of the Authority in a timely fashion.
- 8.0 RECOMMENDATION: It is recommended that the bid of Republic Waste Services be accepted and the resolution be passed authorizing the General Manager to enter into a contract.
