
Section 1. That the Board of Trustees supports the proposed design of the stations and streetscape for the Euclid Corridor Transportation Project.

- 1.0 **PURPOSE/SCOPE:** This action will allow the Authority to support the proposed design of the streetscape and stations for the Euclid Corridor Transportation Project (ECTP).

Per our interagency agreement with the City of Cleveland, the proposed design of the project undergoes review and approval at the City Design Review Committee and City Planning Commission. A Board resolution in support for the designs would be beneficial in seeking these approvals.
