

RESOLUTION NO. 2004 -07

AUTHORIZING THE PAYMENT OF DUES FOR ACTIVE MEMBERSHIP IN THE OHIO PUBLIC TRANSIT ASSOCIATION BY THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY FOR THE 2004 CALENDAR YEAR IN THE AMOUNT OF \$38,296 (GENERAL FUND – EXECUTIVE DEPARTMENT BUDGET)

WHEREAS, the Ohio Public Transit Association (OPTA) represents the interests of public transit in the State of Ohio, primarily with the state administration and state legislature; and

WHEREAS, the Greater Cleveland Regional Transit Authority, through its predecessor the Cleveland Transit System, is a charter member and has supported its efforts throughout OPTA's 32 years of existence; and

WHEREAS, largely through OPTA's efforts, state support for public transit has consistently been increased in each biennium budget; and

WHEREAS, dues to OPTA are levied on a calendar basis.


NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager/Secretary-Treasurer is hereby authorized to pay the Ohio Public Transit Association the sum of \$38,296.00 as the Greater Cleveland Regional Transit Authority dues for active membership in said Association for the calendar year 2004.

Section 2. That said amount shall be payable from the General Fund, Executive Department Budget, in the amount of \$38,296.

Section 3. That this resolution shall become effective immediately upon its adoption.



- 1.0 PURPOSE/SCOPE: This action will allow the GCRTA to remain an active member in the Ohio Public Transit Association (OPTA) during 2004.
- 2.0 DESCRIPTION/JUSTIFICATION: OPTA represents the interests of public transit in the State of Ohio, primarily with the state administration and state legislature. Regulatory and legislative issues at the state level are becoming more and more critical to the Authority.  
  
Dues are based on the following formula: All properties having a total of 100 or more active vehicles - annual membership is \$1,000 per year plus assessment of \$42.00 per operating vehicle.
- 3.0 PROCUREMENT BACKGROUND: Does not apply.
- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: Does not apply
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: Said amount will be payable from the General Fund, Executive Department Budget, in the amount of \$38,296.
