NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

- Section 1. That the Board of Trustees of the Greater Cleveland Regional Transit Authority supports the initiatives OneCleveland.
- Section 2. That the General Manager is authorized to participate in the initiatives of OneCleveland.
- Section 3. That a copy of the resolution will be forwarded to the OneCleveland Advisory Board.
