EXPRESSING APPRECIATION TO PAUL J. VOLPE FOR HIS SERVICE AS A MEMBER OF THE BOARD OF TRUSTEES OF THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY AND EXTENDING BEST WISHES FOR MANY HAPPY YEARS TO COME

WHEREAS, Paul J. Volpe served as a member of the Board of Trustees, having been appointed by the Cuyahoga County Commissioners January 30, 2001, meeting of the Greater Cleveland Regional Transit Authority Board of Trustees, filling an unexpired term, and reappointed for a three-year term beginning March 3, 2001.

WHEREAS, Paul J. Volpe, AIA, is an award-winning architect. In 1989, he became the founding Principal and President of City Architecture, a firm that specializes in city planning and urban design. A strong advocate for sustainable, livable communities, he has presented his views in numerous forums, including the national media. Since 1985, Mr. Volpe has received more than 65 honors and awards for architecture, urban design and neighborhood revitalization.

WHEREAS, Paul J. Volpe served under Mayor George V. Voinovich as Commissioner of Architecture for the City of Cleveland from 1983 to 1989, helping to plan and design more than \$150 million in municipal projects.

WHEREAS, Paul J. Volpe has been Chairman of the Cleveland Landmarks Commission, on the boards of Cleveland Public Art and MidTown Cleveland, a member of the Congress for New Urbanism, National Trust for Historic Preservation, Downtown Cleveland Partnership, Cleveland Restoration Society, Green Building Coalition and numerous other groups and is a graduate of Leadership Cleveland.

WHEREAS, Paul J. Volpe has served with distinction and took an active part as a member of the Planning & Development and Operations Committees and dedicated his expertise to the Euclid Corridor Transportation Project.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the most sincere appreciation of the Board of Trustees is hereby extended to Paul J. Volpe for his dedicated service to the Authority and his community.


