## Resolution No. 2004-7.6

## AUTHORIZING PARTICIPATION IN THE OHIO DEPARTMENT OF TRANSPORATION OFFICE OF CONTRACTS PURCHASING SERVICES COOPERATIVE PURCHASING PROGRAM

WHEREAS, Section 5513.01(B) of the Ohio Revised Code provided the opportunity for Counties, Townships, Municipal Corporations, Conservancy Districts, Township Park Districts, Park Districts created under Chapter 1545 of the Revised Code, Port Authorities, Regional Transit Authorities, Regional Airport Authorities, Regional Water and Sewer Districts, County Transit Boards, State University or Colleges to participate in the contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies or other articles.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Greater Cleveland Regional Transit Authority (General Manager) hereby requests authority in the name of the Greater Cleveland Regional Transit Authority to participate in the Ohio Department of Transportation contracts for the purchase of machinery, material supplies or other articles which the Department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

Section 2. That the General Manager is hereby authorized to agree in the name of the Greater Cleveland Regional Transit Authority to be bound by all terms and conditions as the Director of Transportation prescribes.

Section 3. That the General Manager is hereby authorized to agree in the name of the Greater Cleveland Regional Transit Authority to directly pay vendors, under each such contract of the Ohio Department of Transportation in which the Greater Cleveland Regional Transit Authority participates, for items it receives pursuant to the contract.

Section 4. That the General Cleveland Regional Transit Authority agrees to be responsible for resolution of any claim or dispute arising under contracts it enters into through participation in Ohio Department of Transportation contracts pursuant to Ohio Revised Code Section 5513.01(B).

Section 5. That this resolution shall become effective immediately upon its adoption.
