WHEREAS, the Authority has recurring requirements for replacement of motor coach filters on coaches; and

WHEREAS, the bid of BTMC Corporation located at 156 E. Broadway, Westerville, OH 43081 for the furnishing of motor coach filters, as specified and as required, for a period of one (1) year with a one (1) year option was received on April 15, 2004, at unit prices resulting in an amount not to exceed one hundred ten thousand eight hundred sixty-five & /100 dollars (\$110,865.00) for the base year and an amount not to exceed one hundred ten thousand eight hundred sixty-five & 00/100 dollars (\$110,865.00) for the option year; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of BTMC Corporation to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio.

- Section 1. That the bid of BTMC Corporation received on April 15, 2004 be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.
- Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with BTMC Corporation for the furnishing of motor coach filters, as specified and as required, for a period of one (1) year with the authority to exercise the additional option for one (1) year at the bid price.
- Section 3. That said contract shall be payable from the General Fund, Fleet Management Department budget, in an amount not to exceed one hundred ten thousand eight hundred sixty-five & /100 dollars (\$110,865.00) for the base year and an amount not to exceed one hundred ten thousand eight hundred sixty-five & /100 dollars (\$110,865.00) for the option year.
- Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon funding for future years; compliance by the contractor to the Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2003-107; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Transit Authority's Board of Trustees expects that BTMC Corporation will attempt to exceed the 0% DBE goal assigned to this procurement.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to enter into a contract for the furnishing of motor coach filters, as specified, on a requirement basis for a period of one (1) year with an option for one (1) year.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority has an on going need to replace air, fuel, transmission, engine oil and cooling system filters as normal scheduled maintenance.
- 3.0 PROCUREMENT BACKGROUND: Invitations for bids were sent to twenty-one (21) prospective bidders. Bids were opened on April 15, 2004. There were six (6) bids submitted. A summary of the bids are included as Attachment A.

The bid of BTMC has been determined by the Procurement Department to be a responsive bid from a responsible bidder. A price analysis has been performed and the Procurement Department has determined the price to be fair and reasonable to the Authority.

- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of subcontracting opportunities.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the General Fund, Fleet Management Department budget, in an amount not to exceed \$110,865.00 for the base term of the contract, and an amount not to exceed \$110,865.00 for the option year. The bid price is 8.1% below the budgeted cost for this procurement.
- 7.0 ALTERNATIVES: Reject all bids. Rejection of this award would delay the timely replacement of motor coach filters, which would cause the Authority's coaches to be unsafe and disruptions of service due to inoperable coaches.
- 8.0 RECOMMENDATION: It is recommended that the bid of BTMC Corporation be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
