Section 1. That the General Manager/Secretary-Treasurer is hereby authorized to pay the Ohio Public Transit Association the sum of \$38,669.00 as the Greater Cleveland Regional Transit Authority dues for active membership in said Association for the calendar year 2005.

Section 2. That said amount shall be payable from the General Fund, Executive Department Budget, in the amount of \$38,669.

Section 3. That this resolution shall become effective immediately upon its adoption.
