AUTHORIZING CONTRACT NO. 2005-151 WITH NORRIS AUTO MALL LTD., FOR THE FURNISHING OF EIGHT (8) MID SIZED AUTOMOBILES, AS SPECIFIED, THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM AT A TOTAL PRICE OF \$104,740.40 (RTA CAPITAL FUND – FLEET MANAGEMENT DEPARTMENT BUDGET)

WHEREAS, the Authority has identified the need for eight (8) mid sized automobiles to replace similar vehicles that have exceeded their useful life; and

WHEREAS, the State of Ohio Cooperative Purchasing Act provides political subdivisions within the State of Ohio with the opportunity to participate in contracts executed by the State of Ohio Department of Administrative Services, Office of State Purchasing, for the purchase of supplies, services, equipment and certain materials; and

WHEREAS, Section 306.43(H)(4) of the Ohio Revised Code permits a Regional Transit Authority to participate in said program; and

WHEREAS, the Board of Trustees authorized utilization of the State of Ohio Cooperative Purchasing Program in Resolution 1990-69; and

WHEREAS, these vehicles are available from Norris Auto Mall Ltd., located at 3205 Medina Road, Medina, Ohio 44256 at a total price of one hundred four thousand seven hundred forty & 40/100 dollars (\$104,740.40); and

WHEREAS, the General Manager/Secretary-Treasurer has deemed it in the best interest of the Authority to utilize the State of Ohio Cooperative Purchasing Program for the purchase of eight (8) mid sized automobiles, as specified, from Norris Auto Mall Ltd. and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of Norris Auto Mall Ltd. for the furnishing of eight (8) mid sized automobiles, as specified, be and the same is hereby accepted as in the best interest of the Authority.

Section 2. That the General Manager/Secretary Treasurer of the Authority be and he is hereby authorized to enter into a contract with Norris Auto Mall Ltd. for the furnishing of eight (8) mid sized automobiles, as specified.

Section 3. That said contract shall be payable from the RTA Capital Fund, Fleet Management Department budget at a total price of one hundred four thousand seven hundred forty & 40/100 dollars (\$104,740.40).

Section 4. That said contract shall be binding upon and an obligation of the Authority, contingent upon compliance by the contractor to the Specification and Addenda, if any, the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2005-051; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

- 1.0 PURPOSE/SCOPE: This resolution will allow the Authority to enter into a contract for the purchase of eight (8) mid sized automobiles through the State of Ohio Cooperative Purchasing Program.
- 2.0 DESCRIPTION/JUSTIFICATION: These eight (8) non-revenue vehicles will replace other non-revenue vehicles used by various departments throughout the Authority that have exceeded their useful life and fall within the Authority's vehicle replacement guidelines. The following vehicles are recommended to be removed from service:

3.0 PROCUREMENT BACKGROUND: These vehicles will be purchased from Norris Auto Mall Ltd. through the State of Ohio Cooperative Purchasing Program. The Authority will procure eight (8) Dodge Stratus automobiles at a unit cost of \$13,043.80 along with one complete set of maintenance manuals at a cost of \$390.00. The total contract value is \$104,740.40.

The Board of Trustees has authorized the General Manager/Secretary-Treasurer to utilize the State Cooperative Purchasing Program by Resolution 1990-69. The price established under the state program is a result of a competitive solicitation and offered to all government entities.

A price analysis was performed by the Procurement Department and the price has been determined to be fair and reasonable to the Authority.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: The Office of Business Development does not conduct Affirmative Action reviews or establish goals on procurements included in the State Cooperative Purchasing program.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the RTA Capital Fund, Fleet Management Department budget at a total price of one hundred four thousand seven hundred forty & 40/100 dollars (\$104,740.40). This price is 1% below the budget of \$106,000.00 for this purchase.
- 7.0 ALTERNATIVES: <u>Reject this offer</u>. Rejection of this offer would delay the replacement of non-revenue vehicles and cause the Authority to incur additional expense in the operation and maintenance of non-revenue vehicles.
- 8.0 RECOMMENDATION: It is recommended that the offer of Norris Auto Mall Ltd. be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
