

RESOLUTION NO. 2006-204

AUTHORIZING CONTRACT NO. 2006-113 WITH DOAN/PYRAMID, LLC FOR PROJECT NO. 11.35 – REPLACEMENT OF FEEDER CABLE AT HARVARD GARAGE IN THE AMOUNT OF \$48,350.00 (RTA CAPITAL FUND, ENGINEERING & PROJECT DEVELOPMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to acquire construction services as provided under Project 11.35 – Replacement of Feeder Cable at Harvard Garage; and

WHEREAS, the bid of Doan/Pyramid, LLC located at 5069 Corbin Drive, Bedford Hts., Ohio 44128, was received on November 1, 2006 in the amount of \$48,350.00 to perform said services; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Doan/Pyramid, LLC to be the lowest responsive bid from a responsible bidder for said services and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Doan/Pyramid, LLC be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Doan/Pyramid, LLC for Project 11.35 – Replacement of Feeder Cable at Harvard Garage.


Section 3. That said contract shall be payable from the RTA Capital Fund, Engineering & Project Development Department budget in the amount of forty-eight thousand three hundred fifty & 00/100 dollars (\$48,350.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2006-77; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Doan/Pyramid, LLC will exceed the 20% DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE:** This action will allow the Authority to enter into a contract for the installation of approximately 500 feet of feeder line in the GCRTA Harvard District Bus Garage as described under Project 11.35.
- 2.0 **DESCRIPTION/JUSTIFICATION:** This project will involve the installation of a new underground and overhead feeder cable to replace an existing cable that has failed and cannot be repaired. In addition, explosion-proof cabling will be installed in the fueling bay. At the completion of installation, the temporary feeder cable will be disconnected and the new feeder cable will be placed in service.
- 3.0 **PROCUREMENT BACKGROUND:** The Invitation for Bid was posted on the GCRTA website and advertised in the local newspapers. Three (3) prospective bidders requested packages for this solicitation and three bids were received on November 1, 2006 as follows:

Doan/Pyramid, LLC 5069 Corbin Drive Bedford Hts, Ohio 44128	\$48,350.00
DDC+, Inc. 26285 Broadway Avenue Oakwood Village, Ohio 44146	\$58,000.00
US Utility Contractor Co., Inc. 3592 Genoa Road Perrysburg, Ohio 43551	\$58,105.00

The Basis of Award was to be the lowest responsive bid from a responsible bidder. Doan/Pyramid, LLC was the lowest responsive and responsible bidder.

Doan/Pyramid, LLC is currently working on the Euclid Corridor Transportation Project for the Authority and on similar projects at the Cleveland Clinic Foundation Heart Center and Chiller Plant. They have successfully completed work on the Authority's Triskett Garage project, the Cleveland Hopkins Airport and University Hospitals Health System.

A price analysis was performed and the Procurement Department determined the bid price to be fair and reasonable to the Authority.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 20% DBE goal was established for this procurement. Doan/Pyramid has committed to meet the DBE goal through the utilization of North Electric in an amount of at least \$9,750.00.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the RTA Capital Fund, Engineering & Project Development Department budget in the amount of forty-eight thousand three hundred fifty & 00/100 dollars (\$48,350.00). The price submitted is 16.5% below the Engineer's Estimate of \$58,550.00. The second low bid was less than 1% above the apparent low bid.
- 7.0 ALTERNATIVES: Reject this bid. Rejection of all bids would delay the Authority's ability to maintain reliable service.
- 8.0 RECOMMENDATION: It is recommended that the bid of Doan/Pyramid, LLC be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
