

RESOLUTION NO. 2007-70

AUTHORIZING CONTRACT NO. 2007- 053 WITH GENERAL ELECTRIC COMPANY FOR THIRTY-TWO (32) LINE BREAKERS FOR THE TOKYU HRV FLEET AT A TOTAL PRICE OF \$371,200.00 (RTA DEVELOPMENT FUND, RAIL DISTRICT DEPARTMENT BUDGET)

WHEREAS, the Authority has a need to replace thirty-two (32) line breakers for the Tokyu Heavy Rail Vehicle (HRV) fleet; and

WHEREAS, the Ohio Revised Code, Section 306.43H(2) provides that competitive bidding is not required when a regional transit authority, after reasonable inquiry, determines that only one source of supply is reasonably available; and

WHEREAS, General Electric Company has proprietary rights to the line breakers currently available for use on the Authority's HRV fleet; and

WHEREAS, the offer of General Electric Company, located at 2901 East Lake Road, Erie, PA 16531, to furnish thirty- two (32) line breakers for the Authority's HRV fleet was received on April 30,2007; and

WHEREAS, a negotiated contract price of three hundred seventy one thousand two hundred & 00/100 dollars (\$371,200.00) was agreed upon; and

WHEREAS, the General Manager/Secretary-Treasurer deems the offer of General Electric Company to be fair and reasonable and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of General Electric Company, as negotiated, to provide thirty-two (32) line breakers for the Tokyu HRV fleet be and the same is hereby accepted as in the best interest of the Authority.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a sole source contract with General Electric Company for the furnishing of thirty two (32) line breakers for the HRV fleet.


Section 3. That said contract shall be payable from RTA Development Fund (Heavy Rail Overhaul Project), Rail District Budget, including but not limited to Capital Grant OH-03-0226 at a total price \$371,200.00 (\$296,960.00 in Federal funds which represents 80% of the total cost).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2007-064; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that General Electric Company will attempt to exceed the 0% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

1.0 **PURPOSE/SCOPE:** This action will allow the Authority to enter into a sole source contract for the purchase of thirty-two (32) line breakers, GE part number 17JM9H2C and RTA part number 53-6160, for the Tokyu Heavy Rail Vehicle (HRV) fleet.

2.0 **DESCRIPTION/JUSTIFICATION:** The Tokyu HRV fleet was placed in service in 1985. The line breaker is the main circuit breaker on the Tokyu HRV and it is designed to protect the vehicle's electrical system and components from damage in the event of an electrical surge or short circuit. The breaker would trip before any damage to the components would occur. A number of the line breakers have deteriorated to the point that they are no longer performing the protection that they were designed to perform. The line breaker is identified as part of the HRV mid-life overhaul campaign.

3.0 **PROCUREMENT BACKGROUND:** This sole source is exempt from competitive bidding as authorized by Section 306.43H(2) of the Ohio Revised Code. General Electric Company holds the exclusive rights to this product. An industry survey showed that no other manufacturer provides a comparable line breaker for the HRV vehicles. The Procurement Department requested a proposal from General Electric Company. After negotiations, a price of \$11,600.00 for each of the thirty-two line breakers was agreed upon for a total price of \$371,200.00.

A price analysis was performed and the Procurement Department has determined the negotiated offer to be fair and reasonable to the Authority.

4.0 **AFFIRMATIVE ACTION/DBE BACKGROUND:** All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of subcontracting opportunity.

5.0 **POLICY IMPACT:** Does not apply.

6.0 **ECONOMIC IMPACT:** This procurement will be funded through the Heavy Rail Overhaul Project, RTA Development Fund, Rail District Budget, including but not limited to Capital Grant OH-03-0226, Line Item 12.15.21 at a total price of \$371,200.00 (\$296,960.00 in Federal funds which represents 80% of the total cost). This price is within the budgeted estimate of \$380,800.00. The unit price of \$11,600.00 is approximately 12% above the unit cost previously paid in 2005.

7.0 **ALTERNATIVES:** Reject this offer. Rejection of this offer may potentially cause the unsafe operation of the HRV fleet and may impact the safety of customers, operators, and the service goals of the Authority. The other alternative is to rebuild these units internally utilizing a force account, but due to lack of personnel this is currently an unacceptable alternative.

- 8.0 RECOMMENDATION: It is recommended that the offer of General Electric Company be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
- 9.0 ATTACHMENTS: None.
