AUTHORIZING CONTRACT NO. 2007-117 WITH PERRIN ASPHALT, INC. FOR PROJECT 11.97 – HARVARD GARAGE PAVEMENT REPAIRS IN THE AMOUNT OF \$164,869.00 (RTA DEVELOPMENT FUND, ENGINEERING & PROJECT DEVELOPMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to make pavement repairs to the Harvard Garage as described under Project 11.97; and

WHEREAS, the bid of Perrin Asphalt, Inc. located at 525 Dan Street, Akron, Ohio 44310, for said repairs was received on November 8, 2007 in the amount of \$164,869.00; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Perrin Asphalt, Inc. to be the lowest responsive bid from a responsible bidder for said repairs and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Perrin Asphalt, Inc. for Project 11.97 – Harvard Garage Pavement Repairs, be and the same is hereby accepted.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Perrin Asphalt, Inc. for Project 11.97 – Harvard Garage Pavement Repairs.

Section 3. That said contract shall be payable from the RTA Development Fund, Engineering & Project Development Department budget including but not limited to Capital Grant OH-90-X607 in the amount of \$164,869.00 (\$131,895.20 in Federal funds which represents 80% of the total cost).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2007-064; bonding and insurance requirements; and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects Perrin Asphalt, Inc., to exceed the 15% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE: This action will allow the Authority to enter into a contract for the Harvard Garage Pavement Repairs, Project 11.97.
- 2.0 DESCRIPTION/JUSTIFICATION: This project will make repairs to deteriorated pavement at the Harvard Garage. The work consists of the removal of existing 9" concrete and replacement with new pavement. Associated work includes sub-base proof rolling. This project will enhance the aesthetics and provide safer access to the garage for personnel and equipment. The garage will remain operational during construction.
- 3.0 PROCUREMENT BACKGROUND: The Invitation for Bid was posted on the GCRTA website and advertised in the local newspapers. Eighteen (18) prospective bidders obtained packages. Eleven (11) bids were received on November 8, 2007 as identified in Attachment A Bid Summary.

Prospective Bidders were asked to submit a lump sum bid. The basis of award was the lowest responsive bid from a responsible bidder. The bid of Perrin Asphalt, Inc. submitted the lowest responsive bid from a responsible bidder. Perrin Asphalt, Inc. has successfully completed the Repair of Lift #17 at CBMF and various small purchases for the Authority. They have also performed construction work at Akron Children's Hospital, Akron General Medical Center, Akron Zoo and the University of Akron.

A price analysis has been performed by the Procurement Department and the pricing has been determined to be fair and reasonable to the Authority.

4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 15% DBE goal was established for this procurement. Perrin Asphalt Co., Inc. has committed to achieve the goal through the utilization of McTech Corp., a Certified DBE Firm in the amount of \$24,730.00.

- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement shall be payable from the RTA Development Fund, Engineering and Project Development Department budget including but not limited to Capital Grant OH-90-X607, line item 11.7A.00 in an amount of \$164,869.00 (\$131,895.20 in Federal funds which represents 80% of the total cost). The bid price was 15.6% lower than the Engineer's Estimate of \$195,450.00.
- 7.0 ALTERNATIVES: Reject this bid. Rejection of this award will delay the needed pavement repairs at the Harvard Garage and potentially impact the equipment and service goals of this facility.
- 8.0 RECOMMENDATION: It is recommended that the bid of Perrin Asphalt, Inc., be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
