RESOLUTION NO. 2008-100

AUTHORIZING CONTRACT NO. 2008-112 WITH AMERICAN YOUTH FOR CHRIST, FOR THE SALE OF FORTY-NINE (49) USED TRANSIT VEHICLES IN "AS IS" CONDITION FOR A TOTAL SALE PRICE OF \$161,781.00.

WHEREAS, forty-nine (49) used transit vehicles have been determined to be obsolete in accordance with the Authority's vehicle replacement policy and have been declared excess and will be disposed of in accordance with the Authority's property disposal procedure; and

WHEREAS, the Ohio Revised Code, Section 306.43(K) provides that a regional transit authority shall make a sale or other disposition of property through full and open competition; and

WHEREAS, the bid of American Youth For Christ, located at 32355 Newcastle, Warren, MI 48093 for the purchase of said vehicles was received on June 5, 2008 for a total sale price of one hundred sixty-one thousand seven hundred eighty-one & 00/100 dollars (\$161,781.00); and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of American Youth For Christ, to be the highest responsive bid from a responsible bidder for the items identified in Attachment A, hereto and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of American Youth For Christ, for the purchase of forty-nine (49) used transit vehicles, as listed on Attachment A, be and the same is hereby accepted.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with American Youth For Christ for the sale of fortynine (49) used transit vehicles at a price of one hundred sixty-one thousand seven hundred eighty-one & 00/100 dollars (\$161,781.00); as listed on Attachment A, in "as is" condition in accordance with the terms of the bid hereto, and that such contract is in the best interest of the Authority.

Section 3. That proceeds of said sale in the amount of one hundred sixty-one thousand seven hundred eighty-one & 00/100 dollars (\$161,781.00); shall be deposited into the General Fund.

Section 4. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE: This action will allow the Authority to enter into a contract for the sale of forty-nine (49) used transit vehicles.
- 2.0 DESCRIPTION/JUSTIFICATION: The transit vehicles, as identified in Attachment A to the resolution, have exceeded the useful life criteria established by the Authority's Vehicle Replacement Policy and FTA regulations. These vehicles range in age from 14 to 16 years. These vehicles have deteriorated to such a degree that the cost to return them to a safe and reliable condition would far exceed their value. It is recommended that these vehicles not be repaired, but sold on an "as is" basis.
- 3.0 PROCUREMENT BACKGROUND: Ohio Revised Code, Section 306.43(K) authorizes the sale and disposition of property through full and open competition.

This solicitation was posted on the procurement web site and solicitation notifications were sent to 36 companies and/or individuals. Three (3) bids were received on June 5, 2008 for this sale as listed below. An analysis was performed and the purchase price of American Youth For Christ, for the forty-nine (49) used transit vehicles at a total cost of \$161,781.00 is considered fair and reasonable to the Authority.
