

RESOLUTION NO. 2008-159

AUTHORIZING CONTRACT NO. 2008-261 WITH PRE-TRIP PLUS, LLC,
FOR THE SALE OF FORTY-NINE (49) USED TRANSIT VEHICLES IN "AS
IS" CONDITION FOR A TOTAL SALE PRICE OF \$31,311.00

WHEREAS, forty-nine (49) used transit vehicles have been determined to be obsolete in accordance with the Authority's vehicle replacement policy and have been declared excess and will be disposed of in accordance with the Authority's property disposal procedure; and

WHEREAS, the Ohio Revised Code, Section 306.43(K) provides that a regional transit authority shall make a sale or other disposition of property through full and open competition; and

WHEREAS, the bid of Pre-Trip Plus, LLC, located at 316 Ecorse Road, Suite 200, Ypsilanti, MI 48197 was received on November 6, 2008 for a total sale price of thirty-one thousand three hundred eleven & 00/100 dollars (\$31,311.00); and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Pre-Trip Plus, LLC, to be the highest responsive bid from a responsible bidder for the items identified in Attachment A attached hereto and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Pre-Trip Plus, LLC, for the purchase of forty-nine (49) used transit vehicles, as listed on Attachment A hereto, be and the same is hereby accepted.


Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Pre-Trip Plus, LLC for the sale of forty-nine (49) used transit vehicles at a price of six hundred thirty-nine & 00/100 dollars (\$639.00) each for a total bid price of thirty-one thousand three hundred eleven & 00/100 dollars (\$31,311.00), as listed on Attachment A, in "as is" condition in accordance with the terms of the bid hereto, and that such contract is in the best interest of the Authority.

Section 3. The proceeds of said sale will be deposited in the General Fund at a total sale price of thirty-one thousand three hundred eleven & 00/100 dollars (\$31,311.00).

Section 4. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE: This action will allow the Authority to enter into a contract for the sale of forty-nine (49) used transit vehicles.
- 2.0 DESCRIPTION/JUSTIFICATION: The transit vehicles, as identified in Attachment A to the resolution, have exceeded the useful life criteria established by the Authority's Vehicle Replacement Policy and FTA regulations. These vehicles range in age from 13 to 16 years. These vehicles have deteriorated to such a degree that the cost to return them to a safe and reliable condition would far exceed their value. It is recommended that these vehicles not be repaired, but sold on an "as is" basis.
- 3.0 PROCUREMENT BACKGROUND: Ohio Revised Code, Section 306.43(K) authorizes the sale and disposition of property through full and open competition.

This solicitation was posted on the procurement web site and solicitation notifications were sent to 35 companies and/or individuals. Two (2) bids were received on November 6, 2008 for this sale as listed below. An analysis was performed and the purchase price of Pre-Trip Plus LLC, for the forty-nine (49) used transit vehicles at an average unit price of \$639.00 is considered fair and reasonable to the Authority.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: Does not apply.
- 5.0 POLICY IMPACT: This disposal is consistent with the Greater Cleveland Regional Transit Authority's Vehicle Replacement Policy and the Procurement Policy regarding the sale or disposal of property.
- 6.0 ECONOMIC IMPACT: The proceeds of said sale will be deposited into the General Fund at a total sale price of thirty-one thousand three hundred eleven & 00/100 dollars (\$31,311.00).

- 7.0 ALTERNATIVES: Reject all bids. Rejection of all bids will delay the sale of these used transit vehicles and cause the Authority to incur additional costs in handling and storage of these vehicles.
- 8.0 RECOMMENDATION: It is recommended that the bid of Pre-Trip Plus LLC, be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
