AUTHORIZING THE GENERAL MANAGER/SECRETARY-TREASURER TO ACKNOWLEDGE AND ACCEPT THE ROLES AND RESPONSIBILITIES OF THE GCRTA WITH THE CUYAHOGA COUNTY DIVISION OF EMERGENCY MANAGEMENT'S, CUYAHOGA COUNTY EMERGENCY OPERATIONS PLAN, ESTABLISHING THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY AS THE PRIMARY AGENCY FOR EMERGENCY SUPPORT FUNCTION #1 (TRANSPORTATION) WITH THE PURPOSE OF COORDINATING ALL EMERGENCY TRANSPORTATION RESOURCES FOR THE RESPONSE AND RECOVERY FROM ANY DISASTER IN CUYAHOGA COUNTY AND AS A SUPPORT AND COORDINATION AGENCY FOR EMERGENCY SUPPORT FUNCTION #8 (PUBLIC HEALTH AND MEDICAL SERVICES)

WHEREAS, The Greater Cleveland Regional Transit Authority is the sole primary Public Transportation Provider for Cuyahoga County; and

WHEREAS, the Authority seeks to effectively protect its employees, transit passengers, and the general public from any natural or man made disaster; and

WHEREAS, coordination among federal, state and local law enforcement agencies is critical to establishing an effective response to an emergency; and

WHEREAS, the Cuyahoga County Division of Emergency Management, is the lead local agency coordinating the response to a multi-jurisdictional emergency incident; and

WHEREAS, pursuant to national policy on emergency response as set forth in Presidential Directives, Cuyahoga County EMA is aligning its response to emergencies to conform with the National Response Framework; and

WHEREAS, the General Manager/Secretary-Treasurer has determined that the Transit Authority will benefit by assuming the responsibility as the Primary Agency for Emergency Support Function (ESF) #1 (Transportation) and Support and Coordination Agency for Emergency Support Function (ESF) #8 (Public Health and Medical Services).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. The roles and responsibilities of the GCRTA with the Cuyahoga County Division of Emergency Management's, Cuyahoga County Emergency Operations Plan be and the same is hereby accepted as in the best interest of the public and the Authority.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to accept the roles and the responsibilities of the Authority as specified in the Cuyahoga County Emergency Operations Plan, Emergency Support Function (ESF) #1 (Transportation) and Emergency Support Function (ESF) #8 (Public Health and Medical Services).

- 1.0 PURPOSE/SCOPE: Coordinate all emergency transportation resources for the response to and recovery from any disaster in Cuyahoga County and provide support to health and medical services during and after a disaster by providing transportation for shelter clients, and medical staff.
- 2.0 DESCRIPTION/JUSTIFICATION: In 1991 the GCRTA entered into an agreement with Cuyahoga County under the Cuyahoga Major Emergency Incident Management System (CMEIMS). This new agreement is with the Cuyahoga County Emergency Operations Plan, the replacement agency to CMEIMS.
- 3.0 PROCUREMENT BACKGROUND: None.
- 4.0 DBE/AFFIRMATIVE ACTION BACKGROUND: None
- 5.0 POLICY IMPACT: None.
- 6.0 ECONOMIC IMPACT: The salary of the Authority personnel, overtime costs, vehicle costs, training costs, and associated administrative or investigative costs directly involved in the response to an emergency is the responsibility of the GCRTA. Reimbursement for these costs may be the responsibility of the jurisdiction receiving the services. In a declared emergency and for DHS approved training programs certain costs may be reimbursable through Cuyahoga County, the State of Ohio and/or the Federal Government.
- 7.0 ALTERNATIVES: None.
- 8.0 RECOMMENDATION: It is recommended that the resolution be passed authorizing the General Manager/Secretary-Treasurer to accept the roles and responsibilities in the Cuyahoga County Emergency Operations Plan.

PURPOSE:

Coordinate all emergency transportation resources for the response to and recovery from any disaster in Cuyahoga County.

POLICIES

- Transport vulnerable populations to safe locations.
- Provide transportation services to relocate resources as necessary.
- All County transportation assets under the control of the Board of County Commissioners shall be made available to Emergency Support Function (ESF) #1 upon implementation of the Emergency Operations Plan (EOP).
- Local Municipalities will be requested to provide transportation resources as needed (i.e.: school buses, Senior transport services, etc.)
- Provide mutual aid upon request to impacted areas.

Administrative Responsibilities of Lead Agency

Greater Cleveland Regional Transit Authority (GCRTA)

The CEO or designee is designated as the primary contact and shall staff the Emergency Operations Center (EOC) upon notification and ensure 24-hour staffing coverage.

Train all staff responsible for implementing the Emergency Operations Plan (EOP) and specify their roles in Standard Operating Procedures.

Coordinate roles and responsibilities with support agencies.

Operational Responsibilities of Lead Agency

ESF #1 will coordinate transportation of evacuees to temporary and alternate housing sites.

Stage assets and coordinate transportation resources during recovery operations, to assure transport of essential goods and personnel into the affected area.

Maintain the maximum level of public transportation operations with the resources not allocated to the emergency response effort. When necessary public transportation assets may be diverted for emergency response.

Maintain an inventory of all RTA public transportation assets. The inventory shall include RTA fixed route buses, para-transit vehicles, and other available resources. This inventory shall also contain availability by time of day and day of the week.

Ensure all vehicles are properly maintained to ensure availability during an emergency.

Responsibilities of Support Agencies

Cuyahoga County Department of Central Services

The Director or designee is designated as the primary contact and shall provide liaisons to the Cuyahoga County Emergency Operations Center (EOC) upon notification of activation and to ensure 24-hour staffing coverage.

Coordinate the allocation of all fuel and petroleum products necessary to sustain the emergency transportation system in coordination with lead agency. Provide capability to fuel mutual aid resources for response and recovery assistance.

Provide transportation assets as requested by lead agency.

If necessary, coordinate acquisition of alternative fuel supplies.

Coordinate with ESF #7, for transportation of supplies and materials.

Cuyahoga County Metropolitan Housing Authority

The CEO or designee is designated as the primary contact and shall provide liaisons to the Cuyahoga County Emergency Operations Center (EOC) upon notification of activation and to ensure 24-hour staffing coverage.

Maintain and provide an inventory of available assets.

Provide resources and coordination to assist GCRTA.

Cuyahoga County Sheriff's Office

The Sheriff or designee is designated as the primary contact and shall provide liaisons to the Cuyahoga County Emergency Operations Center (EOC) upon notification of activation and to ensure 24-hour staffing coverage.

Provide for rapid evacuation of affected population by assisting with traffic flow and accessibility to evacuation areas.

Coordinate assets with the CEO or designee from GCRTA.

Cuyahoga County Board of Mental Retardation and Developmental Disabilities

The Superintendent or designee is designated as the primary contact and shall provide liaisons to the Cuyahoga County Emergency Operations Center (EOC) upon notification of activation and to ensure 24-hour staffing coverage

Coordinate and monitor activities regarding victim needs and requests for assistance.

Maintain an inventory of all MRDD transportation assets. This inventory should include availability by time of day and day of the week whenever possible.

Provide transportation assets if available when requested by lead agency.

PURPOSE:

Provide health and medical services during and after a disaster, including: protection of water supply, adequate sanitation, safety of food supplies, medical and morgue services, and preventing or controlling epidemics.

POLICIES

- Provide assessment of health and medical needs
- Provide public health surveillance
- Monitor the availability and utilization of health system assets
- Provide public health and medical-related services, supplies and personnel
- Identify areas in which public health problems are likely to occur
- Provide medical-related information releases and public health recommendations and releases to the public
- Investigate and advise on potential health hazards and medical problems
- Provide assistance and support for mass casualty and mass fatality incidents
- Provide behavioral health assistance and care
- Provide environmental sampling and analysis
- Coordinate with local, state and federal partners
- Procure, store, distribute, dispense, and coordinate delivery of pharmaceutical and durable medical equipment products and services before and after a disaster. (SNS)

Administrative Responsibilities of Lead Agency

Cuyahoga County Board of Health, City of Cleveland Department of Public Health. Shaker Heights Department of Health

Health Commissioner of the Cuyahoga County Health Department or designee is the primary contact and shall staff the Emergency Operations Center (EOC) upon activation and ensure 24-hour staffing coverage based on the level of activation.

Maintain a roster of all support agency contact persons, make necessary notifications, activate support agencies as necessary, and maintain ongoing communications to support mission assignments.

Develop, maintain, and review support agency standard operating guidelines (SOGs) to allow for the efficient and effective implementation of ESF #8.

Coordinate mutual aid and private vendor resource needs to requesting parties within the County, through the proper resource request procedure. Documentation shall be maintained for operational accountability and for purposes of financial reimbursement once local resource capabilities have been exhausted.

Coordinate for the provision of all mutual aid resources to requesting parties outside of the county in accordance with appropriate resource request procedures and based on available assets. Documentation shall be maintained for operational accountability and for purposes of financial reimbursement. Notify Emergency Management Manager.

Train all staff responsible for implementing plan on SOGs including support agency staff.

Coordinate with ODH throughout assessment and response. Coordinate health recovery efforts as needed.

Provide pharmaceuticals, medical equipment and supplies as needed during the emergency.

Operational Responsibilities of Lead Agency

Provide public health assessments at the site of the emergency to determine health needs and priorities.

Prepare an Incident Action Plan, during health related emergencies, to meet the public health and medical needs and priorities to share with the EOC.

Assist with coordination of examinations and analyses of potentially hazardous and contaminated substances throughout the emergency.

Assess and make recommendations concerning the public health needs of emergency responders.

Assist in assessing potable water and wastewater/debris management disposal issues and coordinate the allocation of potable water and wastewater/ Debris Management disposal equipment in coordination with ESF #3 and ESF #10.

Ensure the safety of food.

Collect and coordinate the destruction of contaminated foodstuffs.

Control insects, rodents, and other pests in accordance with SOGs.

Participate in a Joint Information Center.

Provide health information to the public as it relates to contaminated food, water, and any other health related issues in coordination with ESF #14.

Conduct medical needs/damage assessment of the impacted area post-disaster and report finding to the EOC.

Maintain ongoing human health surveillance for affected communities to enable the rapid identification of health-related problems.

Implement prevention and control strategies upon identification of health-related problems.

Coordinate and manage the sheltering of evacuees and disaster victims with special needs.

Assist in the identification, purchase and delivery of required pharmaceuticals, medical supplies and services during biological emergencies.

Coordinate with state agencies regarding health and mental health issues in shelters, Service Centers, Outreach Teams, Incident Management Teams.

Assist the affected population by facilitating connections with public health agencies to coordinate services in ARC shelters, service centers, emergency aid stations, and outreach teams.

Assist in the identification of mass burial sites.

Responsibilities of Support and Coordination Agencies

Cuyahoga County Medical Reserve Corps

Cuyahoga County Medical Reserve Corps shall provide a liaison to the EOC if requested. Maintain the CCMRC database of volunteer personnel.

Assist in the assessment of countywide medical needs during and post-disaster.

Coordinate recruitment of physicians, additional nursing staff, and health professional volunteers for area hospitals, clinics, field hospitals, and other sites in coordination with lead agency.

Cuyahoga County Department of Central Services

Provide potable water, toilets, sanitary supplies, custodial services, facilities management personnel, (electricians and plumber) in accordance with SOPs.

Ensure proper functioning and capacity of electrical systems and maintain proper fueling.

Cuyahoga County Local Fire Rescue Departments

Report medical needs and impact assessment information to the EOC.

Implement procedures to ensure safety and care of emergency responders in accordance with SOPs

Provide critical incident stress debriefing for emergency medical response personnel in accordance with SOPs.

Activities of emergency medical units in Ohio are directed by fire chiefs when the units are attached to fire departments and by the owners/operators of private or government-owned companies.

First Responders at the scene coordinate EMS and request state and federal assistance through the County Emergency Management Agency.

Provide representatives in the Cuyahoga County EOC to coordinate local requests for EMS assistance during emergencies.

Coordinate with ODH ESF #8 when federal medical assistance is activated for Ohio.

Cuvahoga County Sheriff's Office

Provide security at the shelters and other medical facilities as requested by lead agency.

Coordinate with the Medical Examiner to identify victims and notify next of kin.

Provide security escort for the transport of the SNS to the PODS.

Cuvahoga County Local Law Enforcement Agencies

Provide security staffing at the shelters and other medical facilities as requested by lead agency.

Coordinate with the Medical Examiner to identify victims and notify next of kin.

Greater Cleveland Regional Transit Authority

Transport shelter clients upon notification and in accordance with Agreement.

Provide for the transportation of medical staff and supplies to area hospitals as needed upon request of lead agency.

City of Cleveland Division of Water

Monitor countywide water supply on an ongoing basis in coordination with municipal water utilities and notify Health Department of any potential contamination of drinking water in accordance with SOP.

Notify Health Department of non-functional sites. Issue boil alerts to the public when necessary.

Northeast Ohio Regional Sewer District

Monitor the NEORSD system on an ongoing basis. Notify appropriate health department(s) and/or Ohio EPA of non-functional sites, and provide generator power at critical failed facilities.

Cuvahoga County Administrator's Office

Serve as an information and Referral/ Public Information service pre, post and during the event.

Serve as the central public information center to relay important disaster information to the public.

Cuyahoga County Community Mental Health Board

Coordinate the activities necessary to facilitate behavioral health recovery efforts and treatment of victims suffering from disaster related mental disorders by the Mobile Crisis Team and other service provider agencies in treating behavioral health needs.

Coordinate and monitor the state behavioral health activities to address victim needs. Coordinate the provision of appropriate interventions.

Provide behavioral health clinical consultation services to Cuyahoga County EOC staff.

Provide representatives to assist local Mental Health and/or Joint Alcohol, Drug Addiction and Mental Health Services/Boards and Regional, County and Community Mental Health Centers in providing supportive services to disaster victims.

Cuyahoga County Alcohol and Drug Addictions Board

Coordinate the provision of behavioral health consultation services to Cuyahoga County EOC staff regarding ATOD consumers and treatment interventions for high risk sub-population.

Coordinate activities necessary to address post-incident surges in substance abuse service needs following disaster or terrorist events.

In conjunction with the Behavioral Health Emergency Response Team, enlist volunteer assistance from provider network to provide appropriate interventions and supportive services to disaster victims.

Maintain an emergency contact list of all contract providers of the ADAS Board network. Provide representatives to assist local lead agencies, regional, county and community centers in providing supportive ATOD treatment services to disaster victims.

Cuvahoga County Senior and Adult Services

Maintain a current list of the elder care component agencies, their addresses and telephone numbers.

Ensure that elder care component agencies will assist clients in the preparation of a family disaster preparedness plan.

Conduct needs assessment post-disaster of all elder care component members and report status to ESF #8.

Request volunteer assistance through service provider networks, should conditions dictate the need for personnel above what local Cuyahoga County Resources are able to provide.

Greater Cleveland Chapter American Red Cross

Provide resident food at shelters.

ARC will supply blankets to the shelters.

Coordinate with local and state agencies regarding health and mental health issues in shelters, Service Centers, Outreach Teams, Incident Management Teams.

Provide emergency first aid and appropriate referral to medical personnel and facilities as well as supportive counseling to people affected by disasters in shelters, Red Cross facilities and disaster sites.

Coordinate the provision of blood and blood products to the affected population.

Provide health services, mental health support and public/mental health information to the affected population.

Assist the affected population by facilitating connections with public health, medical, and mental health agencies to coordinate services in ARC shelters, service centers, emergency aid stations, and outreach teams.

Support reunification efforts utilizing the "safe and well" website (www.disastersafe-redcross.org), and provide disaster welfare information regarding disaster victims with health or mental health issues.

Monitor shelter residents for signs/symptoms of exposure to known contaminants during a Weapons of Mass Destruction (WMD) event and refer to proper medical facility for care.

Provide tracking of victims (in association with Amateur Radio Services) as per Mass Casualty protocol D-MC-02 Sec. 4.5.

Cuvahoga County Coroner's Office

The Coroner will identify victims and forward official death count to the EOC on a daily basis. The Coroner will provide morgue services.

The County Coroner has jurisdiction over the deceased and is responsible for setting up temporary morgues and coordinating with the Ohio Funeral Directors Association when necessary.

Supply personnel and materials to support mass fatality response and expanded mortuary services in affected jurisdictions.

Cuvahoga County Emergency Management

Coordinate local requests for EMS assistance during emergencies.

Maintain ongoing medical surveillance of affected communities in order to rapidly identify and address emergency medical problems.

Support mass fatality response efforts in affected communities.

Upon direction by CCBH, request pharmaceuticals thru the Strategic National Stockpile.

Coordinate NDMS with local VA when activated in Ohio.

Upon direction by CCBH, request pharmaceuticals thru the Strategic National Stockpile.

Upon direction Emergency Management will request medical supplies and services during emergencies.

American Medical Response

The AMR representative or their designee is designated as the primary contact and shall provide liaisons to the Cuyahoga County Emergency Operations Center (EOC) if needed upon notification of activation and to ensure 24-hour staffing coverage.

Maintain a roster of all support agency contact persons, make necessary notifications, activate support agencies as necessary, and maintain ongoing communications to support mission assignments.

Train all staff responsible for implementing plan on SOGs including support agency staff. Provide ambulance resources if requested.

AMR will assist in the dispatch of private ambulances as requested by the incident commander.

Center for Health Affairs

Assist in Coordination of Hospital supply status.

Assist hospitals in request and retrieval of regional cache of supplies once individual hospital supply has been depleted.

Provide representatives in the Cuyahoga County EOC to coordinate local requests for assistance during emergencies.

Determine additional hospital needs.

Note: If total evacuation of a healthcare facility becomes necessary, it is imperative that these facilities have agreements in place with private vendors for the provision of patient transportation. Recent events have shown that public safety resources will be wholly inadequate to accomplish such a mission during a large-scale incident.


