## RESOLUTION NO. 2010-35

AUTHORIZING CONTRACT NO. 2010-040 WITH STANDARD CONTRACTING AND ENGINEERING INC. FOR THE INSTALLATION OF ADA RAMPS AND SIDEWALKS AT BUS AND TRANSIT STATIONS IN THE AMOUNT OF \$149,529.00 (RTA CAPITAL FUND, ENGINEERING & PROJECT DEVELOPMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to acquire construction services for installation of ADA ramps and sidewalks; and

WHEREAS, the bid of Standard Contracting & Engineering, Inc. located at 6356 Eastland Road, Brook Park, Ohio 44142 was received on April 26, 2010 in the amount of one hundred forty-nine thousand five hundred twenty-nine & 00/100 dollars (\$149,529.00) to perform said services; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Standard Contracting and Engineering Inc. to be the lowest responsive bid from a responsible bidder for said services and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

- Section 1. That the bid of Standard Contracting & Engineering Inc., for the installation of ADA ramps and sidewalks be and the same is hereby accepted.
- Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Standard Contracting & Engineering Inc for the installation of ADA ramps and sidewalks
- Section 3. That said contract is payable from the RTA Capital Fund, Engineering & Project Development Department budget, in the amount of one hundred forty-nine thousand five hundred twenty-nine & 00/100 dollars (\$149,529.00).
- Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2010-028; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Standard Contracting and Engineering Inc. will exceed the 16% DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE: This action will allow the Authority to enter into a contract to provide for installation of ADA ramps and sidewalks at six bus and transit stations.
- 2.0 DESCRIPTION/JUSTIFICATION: This solicitation will allow for the replacement of upgraded ADA ramps and sidewalks at six (6) bus stops, transit centers and rapid transit stations. (Flats-East Bank, West 98 and Cudell, Parma Transit Center, North Coast Station Eastbound Platform, West 3 Station-Eastbound Platform, Euclid Park –N- Ride).
- 3.0 PROCUREMENT BACKGROUND: The Invitation for Bid (IFB) was posted on the GCRTA Procurement web site and advertised in the local newspapers. Solicitation packages were requested by a total of 21 prospective bidders. On April 26, 2010, 4 bids were received as follows:

Standard Contracting & Engineering Inc.	\$149,529.00
Veterans Contracting	\$189,650.00
Platform Cement Inc.	\$206,000.00
Perk Company	\$267,000.00

The bid of Standard Contracting & Engineering, Inc. is 49% lower than the Engineer's Estimate of \$290,000.00. Award is allowable where the total of all bids for the project is less than 10% above the estimate thereof, as provided in Ohio Revised Code 153.

Standard Contracting & Engineering Inc. has worked for GCRTA, City of Bedford, City of Cleveland Water Department and numerous private companies in the area.

A price analysis was performed and the Procurement Department determined the Total Lump Sum Price bid received from Standard Contracting & Engineering Inc. to be fair and reasonable to the Authority.

4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 16% DBE Goal has been established for this procurement. Standard Contracting & Engineering, Inc. has committed to \$25,450 or 17% in DBE participation through the utilization of Pro Construction, Inc. (African American-owned).

- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This contract is payable from the RTA Capital Fund, Engineering and Project Development Department budget, in an amount of one hundred forty-nine thousand five hundred twenty-nine & 00/100 dollars (\$149,529.00).
- 7.0 ALTERNATIVES: Reject this bid. Rejection of this award would delay the Authority's ability to install this important safety enhancement.
- 8.0 RECOMMENDATION: It is recommended that the bid of Standard Contracting & Engineering Inc. be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
