That the General Manager/Secretary-Treasurer is hereby authorized to file Transportation Enhancement Grant Applications as required and execute contracts on behalf of the Greater Cleveland Regional Transit Authority with NOACA for the Clifton Boulevard Transportation Enhancement Project and the University Circle Rapid Transit Station Reconstruction Project.
- Section 2. That the General Manager/Secretary-Treasurer is authorized to include this Resolution of Support with both Transportation Enhancement Grant Applications.
- Section 3. That the General Manager/Secretary-Treasurer is authorized to furnish such additional information as NOACA may require in connection with these applications.
- Section 4. That the General Manager/Secretary-Treasurer of the Greater Cleveland Regional Transit Authority is authorized to accept the funds resulting from the NOACA Transportation Enhancement grant program and that Greater Cleveland Regional Transit Authority will provide the local matching funds for these grants.
- Section 5. That, in the absence of the General Manager/Secretary-Treasurer, the Acting General Manager/Secretary-Treasurer of the Greater Cleveland Regional Transit Authority is hereby authorized to perform any and all of the above-described functions.
