

RESOLUTION NO. 2010-75

AUTHORIZING CONTRACT NO. 2010-086 WITH MYERS EQUIPMENT CORPORATION FOR THE PURCHASE OF FIVE LIGHT DUTY TRANSIT VEHICLES, AS SPECIFIED, THROUGH THE OHIO DEPARTMENT OF TRANSPORTATION COOPERATIVE PURCHASING PROGRAM AT A TOTAL PRICE NOT TO EXCEED \$218,710.00 (ON BEHALF OF THE SENIOR TRANSPORTATION CONNECTION)

WHEREAS, the Authority has offered to coordinate the procurement and administration of five (5) light duty transit vehicles on behalf of the Senior Transportation Connection (STC); and

WHEREAS, such vehicles are available through the State of Ohio, Department of Transportation, Office of Contracts Purchasing Services Cooperative Purchasing Program (Cooperative Purchasing Program); and

WHEREAS, Section 5513.01(B) of the Ohio Revised Code provides political subdivisions within the State of Ohio, including agencies, such as, the Senior Transportation Connection (STC) of Cuyahoga County, with the opportunity to participate in contracts executed by the State of Ohio under the Cooperative Purchasing Program for the purchase of machinery, materials, supplies, or other articles; and

WHEREAS, STC has determined it is in their best interest to procure the required vehicles utilizing the Cooperative Purchasing Program; and

WHEREAS, the Board of Trustees authorized utilization of the Cooperative Purchasing Program by Resolution 1990-69; and

WHEREAS, the General Manager/Secretary-Treasurer acknowledges it is in STC's best interest to utilize the Cooperative Purchasing Program for the purchase of five (5) light duty transit vehicles, as specified.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Myers Equipment Corp., for the purchase of five (5) light duty transit vehicles, as specified.


Section 2. That said contract is entered into under the authority granted by the Ohio Revised Code, Section 5513.01(B) and under the terms of the Cooperative Purchasing Program.

Section 3. The vehicles will be purchased by GCRTA on behalf of the Senior Transportation Connection. Eighty-eight percent (88%) will be funded by Grants OH-12-X001 and OH-03-0272. The local share portion will be paid by the Senior Transportation Connection.

Section 4. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE/SCOPE:** This resolution will allow the Authority to enter into a contract with Meyers Equipment Corp., on behalf of the Senior Transportation Connection of Cuyahoga County (STC) for five light duty transit vehicles from the Ohio Department of Transportation Cooperative Purchasing Agreement.
  
- 2.0 **DESCRIPTION/JUSTIFICATION:** The Authority will provide procurement and administrative support for STC for the purchase of five light duty vehicles.
  
- 3.0 **PROCUREMENT BACKGROUND:** Section 5513.01(B) of the Ohio Revised Code provides political subdivisions within the State of Ohio, including agencies such as the Senior Transportation Connection of Cuyahoga County, the opportunity to participate in contracts executed by the State of Ohio under the Cooperative Purchasing Program.
 

Supreme Candidate Wide Body LTV, 2011 Ford model E350 RV 21 ft. cutaway with 5.4 gas engine will be purchased through the Ohio Department of Transportation Cooperative Purchasing Program under Bid # 248-10 at a price not to exceed \$43,742.00 per vehicle.

The Board of Trustees has authorized the General Manager/Secretary to utilize the Ohio Department of Transportation Cooperative Purchasing Program by Resolution 2004-76. The price established under the state program is the result of a competitive bidding process. Contract award is contingent upon the successful review of all cost associated with this procurement and compliance with Pre-Award/Buy America Audit requirements

A cost and price analysis was performed by the Procurement Department and it has been determined that the price is fair and reasonable to the Authority.
  
- 4.0 **AFFIRMATIVE ACTION/DBE BACKGROUND:** All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to lack of certified DBE Firms.
  
- 5.0 **POLICY IMPACT:** Does not apply.

- 6.0 **ECONOMIC IMPACT:** The vehicles will be purchased by GCRTA on behalf of the Senior Transportation Connection. Eighty-eight percent (88%) will be funded by Grants OH-12-X001 and OH-03-0272. The local share portion will be paid by the Senior Transportation Connection.
- 7.0 **ALTERNATIVES:** Reject this offer. Rejection of this offer would cause delays in the procurement of much needed vehicles for the Senior Transportation Connection of Cuyahoga County.
- 8.0 **RECOMMENDATION:** It is recommended that the offer of Meyers Equipment Corp. be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
