

RESOLUTION NO. 2011-40

AUTHORIZING CONTRACT NO. 2011-065 WITH GENERAL ELECTRIC TRANSPORTATION PARTS, LLC FOR ELEVEN (11) MAIN CONTROLLER GROUPS FOR THE TOKYU HRV FLEET AT A PRICE OF \$1,409,650.00 (RTA DEVELOPMENT FUND, RAIL DISTRICT DEPARTMENT BUDGET)

WHEREAS, there is a need to replace eleven (11) Main Controller Groups needed to complete the Tokyu Heavy Rail Vehicle (HRV) mid-life overhaul project; and

WHEREAS, the Ohio Revised Code, Section 306.43H(2) provides that competitive bidding is not required when a regional transit authority, after reasonable inquiry, determines that only one source of supply is reasonably available; and

WHEREAS, General Electric Transportation Parts, LLC has proprietary rights to the Main Controller Groups currently available for use on the Authority's HRV fleet; and

WHEREAS, the offer of General Electric Transportation Parts, LLC located at 2901 East Lake Road, Erie, PA 16531, to furnish eleven (11) Main Controller Groups for the Authority's HRV fleet was received on April 25, 2011; and

WHEREAS, a negotiated contract price of one million four hundred nine thousand six hundred fifty & 00/100 dollars (\$1,409,650.00) was agreed upon; and

WHEREAS, the General Manager/Secretary-Treasurer deems the offer of General Electric Transportation Parts, LLC to be fair and reasonable and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of General Electric Transportation Parts, LLC, as negotiated, to provide eleven (11) Main Controller Groups for the Tokyo HRV fleet be and the same is hereby accepted.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with General Electric Transportation Parts, LLC for the furnishing of eleven (11) Main Controller Groups for the HRV fleet mid-life overhaul, as specified.

Section 3. That said contract shall be payable from RTA Development Fund, Rail District Department budget, including but not limited to Capital Grant OH-05-0097, at a price of \$1,409,650.00 (\$1,127,720.00 in Federal funds which represents 80% of the total cost).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon funding for future years, compliance by the contractor to the Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2011-34; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that General Electric Transportation Parts, LLC will attempt to exceed the 0% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE/SCOPE:** This action will allow the Authority to enter into a sole source contract for the purchase of eleven (11) Main Controller Groups (whole units) for the Tokyu HRV fleet.

- 2.0 **DESCRIPTION/JUSTIFICATION:** The Tokyu HRV fleet was placed in service in 1985. A Main Cam Controller Group controls modes of acceleration and deceleration of the HRV. The power driven controllers set up the motoring and dynamic braking circuits that control low and high voltage relays, which control the traction motors. A defective group will result in an inoperable vehicle. General Electric Transportation Parts, LLC is the original equipment manufacturer and is the sole supplier of this equipment. These units are required as part of the HRV mid-life overhaul project and will be the final controllers needed to complete the project.

- 3.0 **PROCUREMENT BACKGROUND:** This sole source procurement is exempt from competitive bidding as authorized by Section 306.43H(2) of the Ohio Revised Code. General Electric Company holds the exclusive rights to this product, including patents and date rights restrictions. An industry survey showed that no other manufacturer provides a comparable main cam controller group. The Procurement Department requested a proposal from General Electric Transportation Parts, LLC. After negotiations, a price of \$128,150.00 for each of the eleven main control groups was agreed upon. This part is unique to GCRTA and no comparison of prices paid by others is available. In 2009 fifteen controllers were purchased at a unit cost of \$116,500. The cost increase is representative of the two years that have elapsed since the previous procurement as well as the reduced quantity in 2011.

A price analysis was performed and the Procurement Department has determined the negotiated offer to be fair and reasonable to the Authority.

- 4.0 **AFFIRMATIVE ACTION/DBE BACKGROUND:** All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of certified DBE firms.

- 5.0 **POLICY IMPACT:** Does not apply.

- 6.0 **ECONOMIC IMPACT:** This procurement will be funded through the RTA Development Fund, Rail District Department budget, including but not limited to Capital Grant OH-05-0097, Line Item 12.15.21 at a total price of \$1,409,650.00 (\$1,127,720.00 in Federal funds which represents 80% of the total cost). The unit price of \$128,150.00 is 4% above the unit cost previously paid in 2009.

- 7.0 **ALTERNATIVES:** Reject this offer. Rejection of this offer may negatively impact meeting of service requirements and will not allow for the completion of the HRV mid-life overhaul.

8.0 RECOMMENDATION: It is recommended that the offer of General Electric Transportation Parts, LLC be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
