EXPRESSING CONGRATULATIONS TO ALLAN C. KRULAK AS HE RETIRES FROM FOREST CITY ENTERPRISES AND EXTENDING SINCERE BEST WISHES

WHEREAS, Allan C. Krulak, an appointee of Cuyahoga County served two terms with distinction on the Board of Trustees of the Greater Cleveland Regional Transit Authority from March 3, 2000 to June 20, 2006; and

WHEREAS, Allan C. Krulak and his employer, Forest City Enterprises, have earned a well-deserved reputation throughout Greater Cleveland as staunch and loyal supporters of public transit; and

WHEREAS, Allan C. Krulak has worked at Forest City Enterprises for more than 30 years. In his position as Vice President and Director of Community Affairs, he has been a sparkplug for this city's growth and development. His dedicated involvement made a real difference in groups such as the Downtown Cleveland Partnership (now the Downtown Cleveland Alliance) and the Greater Cleveland Growth Association (now the Greater Cleveland Partnership), Leadership Cleveland, and numerous civic and non-profit groups; and

Krulak has been politically active "behind the scenes" for more than 30 years, serving as a valued advisor to a host of elected officials at the local, county, state and federal levels. He has helped raise countless dollars for candidates, elected officials and key issues that have shaped our community; and

WHEREAS, Allan C. Krulak served the City of Pepper Pike for 30 years in positions ranging from Precinct Committeeman to Ward Leader, Councilman and Vice Mayor. He left office on December 31, 2011. His sincerity, experience, hard work and gentlemanly manners helped guide that city to its current position as one of the most highly-ranked suburbs in the area; and

WHEREAS, Allan C. Krulak was inducted into the Distinguished Alumni Hall of Fame at Cleveland Heights High School, and has received numerous awards for his civic leadership, his efforts to help local charities and his contributions to the building industry; and


WHEREAS, Allan C. Krulak has announced his plans to retire from Forest City Enterprises.
