

RESOLUTION NO. 2012-49

AUTHORIZING CONTRACT NO. 2012-053 WITH CROSSROADS ASPHALT & RECYCLING, INC. UNDER PROJECT 13.93 FOR THE STRONGSVILLE PARK-N-RIDE PAVEMENT REHABILITATION, AS SPECIFIED AND AS REQUIRED, IN AN AMOUNT NOT TO EXCEED \$732,900.00 (RTA DEVELOPMENT FUND, ENGINEERING & PROJECT DEVELOPMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to acquire construction services, as provided under Project 13.93, Strongsville Park-N-Ride Pavement Rehabilitation; and

WHEREAS, the bid of Crossroads Asphalt & Recycling, Inc., located at 13421 Hawke Road, Columbia Station, Ohio 44028, was received on May 16, 2012 in an amount not to exceed seven hundred thirty two thousand nine hundred dollars & 00/100 (\$732,900.00) to perform said services; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Crossroads Asphalt & Recycling, Inc. to be a responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Crossroads Asphalt & Recycling, Inc. for Project 13.93, Strongsville Park-N-Ride Pavement Rehabilitation be and the same is hereby accepted.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Crossroads Asphalt & Recycling, Inc. for Project 13.93, Strongsville Park-N-Ride Pavement Rehabilitation

Section 3. That said contract shall be payable from the RTA Development Fund, Engineering & Project Development Department budget, including but not limited to State of Good Repair Capital Grant OH-04-0085 in an amount not to exceed \$732,900.00 (\$586,320.00 in Federal funds which represents 80% of the total cost). The award of this contract is based on initially using available 100% Local funds, which will be replaced by FTA funds when Grant OH-04-0085 is approved and executed.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, thereto, if any: the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2012-036; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Authority's Board of Trustees expects that Crossroads Asphalt & Recycling, Inc. will exceed the 0% DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE/SCOPE:** This action will allow the Authority to enter into a contract to provide construction services for Project No. 13.93, Strongsville Park-N-Ride Pavement Rehabilitation.
- 2.0 **DESCRIPTION/JUSTIFICATION:** The project involves the renewal and repair of the asphalt pavement at the Strongsville Park-N-Ride. The existing pavement has deteriorated from the effects of sun and weather.
- 3.0 **PROCUREMENT BACKGROUND:** The Invitation for Bid (IFB) was posted on the GCRTA Procurement website and advertised in the local newspaper. Fifteen (15) prospective bidders downloaded the solicitation package. Six (6) responsive and responsible bids were received and opened on May 16, 2012 as follows:

The Basis of Award is the lowest responsive and responsible bid for the Total Base Bid/Lump Sum Price. The base bid price of \$732,900.00 from Crossroads Asphalt & Recycling, Inc. is 18.6% below the Engineer's Estimate of \$900,000.00. A price analysis was performed and the Procurement Department has determined that the bid from Crossroads Asphalt & Recycling, Inc. is fair and reasonable to the Authority.

- 4.0 **AFFIRMATIVE ACTION/DBE BACKGROUND:** All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of certified DBE firms
- 5.0 **POLICY IMPACT:** Does not apply.

- 6.0 ECONOMIC IMPACT: This procurement shall be payable through the RTA Development Fund, Engineering & Project Development Department budget, including but not limited to State of Good Repair Capital Grant OH-04-0085, Line Item 11.33.04, in an amount not to exceed \$732,900.00 (\$586,320.00 in Federal funds which represents 80% of the total cost). The award of this contract is based on initially using available 100% Local funds, which will be replaced by FTA funds when Grant OH-04-0085 is approved and executed.
- 7.0 ALTERNATIVES: Reject all bids. Rejection of this offer will create a safety hazard for passengers and employees that use the Strongsville Park-N-Ride facility.
- 8.0 RECOMMENDATION: It is recommended that the bid of Crossroads Asphalt & Recycling, Inc. is accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
