Section 1. That Brad Chase be recognized and commended for his support of transit as evidenced by his active participation on the Authority's Citizens Advisory Board.

Section 2. That the above member wishes to continue his membership on the Citizens Advisory Board (CAB) and that the extension of his term is highly recommended by the Citizens Advisory Board.

Section 3. That the term of membership for Brad Chase be extended for a period of three (3) years as a member of the Citizens Advisory Board (CAB).
