AUTHORIZING CONTRACT NO. 2013-004 WITH ANCHOR CLEANING CONTRACTORS, INC. FOR THE FURNISHING OF WINDOW, BUILDING AND CANOPY CLEANING FOR THREE YEARS, AS SPECIFIED, AT A TOTAL PRICE NOT TO EXCEED \$261,561.00 (GENERAL FUND, SERVICE MANAGEMENT DEPARTMENT BUDGET)

WHEREAS, the Authority requires the services of a professional cleaning company for the continued cleaning of the Authority's windows, buildings and canopies at our facilities; and

WHEREAS, the bid of Anchor Cleaning Contractors, Inc. located at 3625 Independence Road, Cleveland, OH 44102 for the furnishing of window, building and canopy cleaning for a period of three years, as specified, was received on March 4, 2013 for the unit prices set for in said bid, in an amount not to exceed two hundred sixty-one thousand five hundred sixty-one & 00/100 dollars (\$261,561.00); and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Anchor Cleaning Contractors, Inc. to be the lowest responsive bid from a responsible bidder for said services and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Anchor Cleaning Contractors, Inc. for the furnishing of window, building and canopy cleaning be and the same is hereby accepted as a responsive bid from a responsible bidder.

- Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Anchor Cleaning Contractors, Inc. for the furnishing of window, building and canopy cleaning for a period of three years, as specified.
- Section 3. That said contract shall be payable from the General Fund, Service Management Department budget in an amount not to exceed two hundred sixty-one thousand five hundred sixty-one & 00/100 dollars (\$261,561.00) for a period of three years.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon appropriation of funds for future years, compliance by the contractor to the Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 2012-036; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Anchor Cleaning Contractors, Inc. will exceed the 20% minimum DBE goal assigned to this project.

- 1.0 PURPOSE/SCOPE: This resolution will allow the Authority to enter into a contract for the furnishing of window, building and canopy cleaning, as specified.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority has 13 facilities requiring weekly window washing, 11 locations requiring bi-weekly window washing, 17 locations requiring monthly window washing, 3 locations requiring quarterly window washing, 4 locations requiring semi-annual washing to building exteriors, 4 locations requiring annual washing to building exteriors, and 8 rail stairway canopies requiring semi-annual cleaning. The contractor is responsible for providing the entire window, building and canopy washings at these locations. A summary of the facility locations and service information is attached.
- 3.0 PROCUREMENT BACKGROUND: The Invitation for Bid (IFB) was posted on the GCRTA web site and advertised in the local newspapers. Twenty-eight potential vendors downloaded the bid packages with two bidders responding. Bids were opened on March 4, 2013 with the following results:

The Basis of Award is to the lowest responsive bid received from a responsible bidder. The bid of Anchor Cleaning Contractors, Inc. has been determined by the Procurement Department to be a responsive bid from a responsible bidder.

A price analysis has been performed and the Procurement Department has determined that the price is fair and reasonable to the Authority based upon historic pricing.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 20% DBE goal was established for this procurement. Anchor Cleaning Contractors, Inc. has committed to meet the DBE goal through the utilization of QKP Services, LLC (African American owned) in the amount of \$52,572 or 20%.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: That said contract shall be payable from the General Fund, Service Management Department budget in an amount not to exceed two hundred sixty-one thousand five hundred sixty-one & 00/100 dollars (\$261,561.00) for a period of three years. The bid is 30% below the independent cost estimate and 15% below the previous contract pricing.
- 7.0 ALTERNATIVES: Reject this bid. Rejection of this bid would delay the procurement of these services and risk negative public perception and low employee moral resulting from unclean windows, buildings and canopies. It would also cause the Authority to expend additional funds for these services. The Authority does not have the equipment or manpower to do this work in-house. Therefore, if this bid is rejected. Authority window, building and canopy cleaning will not be completed.
- 8.0 RECOMMENDATION: It is recommended that the bid of Anchor Cleaning Contractors, Inc. be accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
