NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the Board of Trustees of the Greater Cleveland Regional Transit Authority hereby authorizes a Grant Agreement with the Cleveland Foundation to accept a \$100,000 grant from the foundation to sponsor a "ride free day" on January 16, 2014.

Section 2. That the General Manager/Secretary-Treasurer is authorized to enter into a Grant Agreement with the Cleveland Foundation to cover the cost of the "ride free day".

Section 3. GCRTA's Board of Trustees and its management express sincere thanks to the Cleveland Foundation on behalf of GCRTA customers for the "birthday gift" grant, as well as for the opportunity to introduce more people to GCRTA by this sponsorship.
