

RESOLUTION NO. 2014-69

AUTHORIZING CONTRACT NO. 2014-094 WITH FEGHALI BROTHERS, LLC FOR PROJECT 15.64 – W. 25TH STREET RAPID TRANSIT STATION REVITALIZATION, AS SPECIFIED AND AS REQUIRED, IN AN AMOUNT NOT TO EXCEED \$105,900.00 (RTA CAPITAL FUND, ENGINEERING & PROJECT DEVELOPMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to acquire construction services, as provided under Project 15.64 – W. 25th Street Rapid Transit Station Revitalization; and

WHEREAS, the bid of Feghali Brothers, LLC, located at 4636 Beech Ct., Canfield, Ohio 44006, was received on July 30, 2014 in an amount not to exceed \$105,900.00 to perform said services; and

WHEREAS, the General Manager/Secretary-Treasurer deems the bid of Feghali Brothers, LLC, to be a responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Feghali Brothers, LLC, for Project 15.64 – W. 25th Street Rapid Transit Station Revitalization be and the same is hereby accepted.

Section 2. That the General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Feghali Brothers, LLC, for Project 15.64 – W. 25th Street Rapid Transit Station Revitalization.


Section 3. That said contract shall be payable from the RTA Capital Fund, Engineering & Project Development Department budget, including but not limited to, 100% Local Funds for a total contract amount not to exceed \$105,900.00.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon future funding, compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2013-31; bonding and insurance requirements; and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Feghali Brothers, LLC will attempt to exceed the 20% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE/SCOPE:** This action will allow the Authority to enter into a contract to provide construction services for Project 15.64, W. 25th Street Rapid Transit Station Revitalization.
- 2.0 **DESCRIPTION/JUSTIFICATION:** This project involves the revitalization of the GCRTA's West 25th Street Rapid Transit Station. The work involves painting the station's structural framing and repairing portions of the existing guard rail system at street level.
- 3.0 **PROCUREMENT BACKGROUND:** The Invitation for Bid (IFB) was posted on the GCRTA Procurement website and advertised in the local newspaper. Twenty-Seven (27) prospective bidders downloaded the solicitation package. Four (4) bids were received and opened on July 30, 2014 but only three (3) bids were determined to be responsive, as follows:

Company Name	Total Base Bid
Feghali Brothers, LLC	\$105,900.00
Kastra, LLC	\$123,700.00
Southwest Companies, Inc.	\$150,985.00

The Basis of Award is the lowest responsive and responsible bid for the Total Base Bid/Lump Sum Price. The Total Base Bid price of \$105,900.00 from Feghali Brothers, LLC is 29.43% lower than the Engineer's Estimate of \$150,055.00. Feghali Brothers, LLC was determined to be a responsible bidder.

- 4.0 **AFFIRMATIVE ACTION/DBE BACKGROUND:** All Affirmative Action requirements have been met. A 20% DBE goal was established for this procurement. Feghali Brothers, LLC has committed to meeting the DBE goal through the utilization of Sallie's Wholesale Construction (Female-owned) for a total of \$26,731.00 or 25%.
- 5.0 **POLICY IMPACT:** Does not apply.
- 6.0 **ECONOMIC IMPACT:** This procurement shall be payable through the RTA Capital Fund, Engineering & Project Development Department budget, including but not limited to, 100% Local Funds for a total contract amount not to exceed \$105,900.00.
- 7.0 **ALTERNATIVES:** Reject this offer. Rejection of this offer will allow for the W. 25th Street Rapid Transit Station to fall into disrepair.

- 8.0 RECOMMENDATION: It is recommended that the bid of Feghali Brothers, LLC is accepted and the resolution passed authorizing the General Manager/Secretary-Treasurer to enter into a contract.
- 9.0 ATTACHMENTS: None.
