

RESOLUTION NO. 2016-39

AUTHORIZING CONTRACT NO. 2016-054 WITH BROWNING-FERRIS INDUSTRIES OF OHIO, INC. DBA REPUBLIC SERVICES, INC. TO PROVIDE RUBBISH COLLECTION SERVICES IN AMOUNT NTE \$302,381.04 FOR THE THREE YEAR PERIOD AND IN AMOUNTS NTE \$103,888.08 AND \$105,877.92 FOR THE TWO OPTION YEARS (GENERAL FUND, SERVICE MANAGEMENT DEPARTMENT BUDGET) AND FOR RECYCLING COLLECTION SERVICES IN AMOUNT NTE \$27,267.60 FOR THE THREE YEAR PERIOD AND IN AMOUNTS NTE \$9,378.48 AND \$9,812.04 FOR THE TWO OPTIONS YEARS (GENERAL FUND, OFFICE OF MANAGEMENT AND BUDGET DEPARTMENT BUDGET) FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$558,605.16 FOR THE FIVE YEAR PERIOD

WHEREAS, the Authority requires rubbish and recycling collection services for its facilities, rapid transit and comfort stations; and

WHEREAS, the bid of Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. located at 8123 Jones Road, Cleveland, Ohio 44105, to provide rubbish and recycling collection services, was received on May 11, 2016 in an amount not to exceed \$329,648.64 for a three year period with two, one-year options not to exceed \$228,956.52 for a total contract amount not to exceed \$558,605.16 for the five year period; and

WHEREAS, the CEO, General Manager/Secretary-Treasurer deems the bid of Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. to be the lowest responsive bid from a responsible bidder for said services and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. to provide rubbish and recycling collection services be and the same is hereby accepted as a responsive bid from a responsible bidder.

Section 2. That the CEO, General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. to provide rubbish and recycling collection services, as specified, for a period of three years with the authority to exercise two, one-year options.


Section 3. That said contract shall be payable from the General Fund, Service Management Department budget in an amount not to exceed \$302,381.04 for a period of three years, and in amounts not to exceed \$103,888.08 and \$105,877.92 for the two option years, for a total amount not to exceed \$512,147.04 for rubbish collection services and from the General Fund, Office of Management and Budget Department budget in an amount not to exceed \$27,267.60 for a period of three years, and in amounts not to exceed \$9,378.48 and \$9,812.04 for the two options years, for a total amount not to exceed \$46,458.12 for recycling collection services, resulting in a total contract amount not to exceed \$558,605.16 for the five year period.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon appropriation of funds for future years, compliance by the contractor to the Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 2015-076; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Browning Ferris Industries of Ohio, Inc. dba Republic Services, Inc. will exceed the 0% minimum DBE goal assigned to this project.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 **PURPOSE/SCOPE:** This resolution will allow the Authority to enter into a contract for rubbish and recycling collection services for a period of three years with two, one-year options.
- 2.0 **DESCRIPTION/JUSTIFICATION:** The Authority contracts for regularly scheduled collection of rubbish from all of our facilities. The contractor will provide scheduled and on-call pick-up of solid waste at all the specified locations. This contract will include recycling collection at eight operating locations. The goal is to reduce and divert the amount of landfill waste.
- 3.0 **PROCUREMENT BACKGROUND:** The Invitation for Bid (IFB) was posted on the GCRTA website and advertised in the local newspapers. Three interested parties downloaded the bid package with one bidder responding. The responsive bid from Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. was opened on May 11, 2016 with the following result:



The Basis of Award is to the lowest responsive bid received from a responsible bidder. The bid of Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. has been determined by the Procurement Department to be a responsive bid from a responsible bidder. The bid is 16% below the previous contract pricing.

A price analysis has been performed and the Procurement Department has determined that the price is fair and reasonable to the Authority based upon historic pricing.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 0% DBE goal was established for this procurement due to the lack of certified DBE firms.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: That said contract shall be payable from the General Fund, Service Management Department budget, in an amount not to exceed \$302,381.04 for a period of three years, and in amounts not to exceed \$103,888.08 and \$105,877.92 for the two option years, for a total amount not to exceed \$512,147.04 for rubbish collection services and from the General Fund, Office of Management and Budget Department budget in an amount not to exceed \$27,267.60 for a period of three years, and in amounts not to exceed \$9,378.48 and \$9,812.04 for the two options years, for a total amount not to exceed \$46,458.12, for recycling collection services, resulting in a total contract amount not to exceed \$558,605.16 for the five-year period. The total contract amount is 16% less than the previously contracted amount for this procurement.
- 7.0 ALTERNATIVES: Reject this bid. Rejection of this bid would delay the procurement of these services and risk not having rubbish or recycling collected. In addition to becoming a health hazard, it would adversely affect the Authority's ability to meet the goals of its Zero Waste at Work Initiative.
- 8.0 RECOMMENDATION: It is recommended that the bid of Browning-Ferris Industries of Ohio, Inc. dba Republic Services, Inc. be accepted and the resolution passed authorizing the CEO, General Manager/Secretary-Treasurer to enter into a contract.
- 9.0 ATTACHMENTS: None.
