

RESOLUTION NO. 2016-82

AUTHORIZING AN INTERGOVERNMENTAL TRANSFER OF ONE (1) NOVA  
40 FT. BUS TO THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY IN "AS  
IS" CONDITION

WHEREAS, the Toledo Area Regional Transit Authority, has requested that the Greater Cleveland Regional Transit Authority transfer one (1) excess Nova 40 ft. bus to meet their service levels requirements; and

WHEREAS, the Federal Transportation Administration (FTA) encourages intergovernmental transfers of federally funded property among agencies; and

WHEREAS, bus 9964 has been declared excess and is scheduled to be disposed of by the Greater Cleveland Regional Transit Authority; and

WHEREAS, pursuant to Ohio Revised Code Section 306.43 (L) (4), the disposition of property by a regional transit authority to a department of the federal or state government, to a political subdivision of the state, or to any governmental entity is exempt from the competitive procurement process; and

WHEREAS, the Board of Trustees deems the transfer of one (1) Nova 40 ft. bus to the Toledo Area Regional Transit Authority to be in the best interest of the Authority.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the CEO, General Manager/Secretary Treasurer is hereby authorized to transfer title of ownership of one (1) Nova 40 ft. bus in "as is" condition to the Toledo Area Regional Transit Authority, with an office at 1127 West Central Avenue, Toledo, OH 43697, on such terms and conditions as he deems appropriate to protect the interest of the Authority.

Section 2. That the CEO, General Manager/Secretary Treasurer is authorized to execute all documents necessary for such transfer.

Section 3. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to transfer title of one revenue vehicle designated as excess property in "as is" condition to the Toledo Area Regional Transit Authority.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority has identified bus number 9964, for intergovernmental transfer to the Toledo Area Regional Transit Authority. It is recommended that this property be transferred in accordance with Section 306.43(L)(4) of the Ohio Revised Code.

- 3.0 PROCUREMENT BACKGROUND: Pursuant to Ohio Revised Code 306.43(L)(4), the disposition of property by a regional transit authority to a department of the federal or state government, to a political subdivision of the state, or to any governmental entity is exempt from the competitive procurement process.
- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: Does not apply.
- 5.0 POLICY IMPACT: This disposal is consistent with the Greater Cleveland Regional Transit Authority's policy regarding disposition of property.
- 6.0 ECONOMIC IMPACT: No money will be generated from this transfer, nor will there be an expenditure of funds. Toledo Area Regional Transit Authority will assume all costs incurred with this transaction.
- 7.0 ALTERNATIVES: Rejection of this offer will require the GCRTA to dispose of this bus through the on-line auction process.
- 8.0 RECOMMENDATION: It is recommended that the Board of Trustees authorize the transfer of the designated excess bus to the Toledo Area Regional Transit Authority.
