This project includes installing a layover roof system, repairing indicated wet areas, removing existing gravel, replacing four skylights, seal existing curved metal roof, and replacing all flashing and other roofing accessories.

# SUMMARY OF AWARD Main Office Building Roof Replacement

## PROJECT OVERVIEW:

The Greater Cleveland Regional Transit Authority (GCRTA) has the need to replace the Main Office Building roof. The work to be performed under this contract includes, but is not limited to, removal and installation of insulation, a 2-ply modified roof system, fans, piping, skylights, and adjustment of roof ladders, among other tasks.

## PROCUREMENT OVERVIEW:

The Invitation for Bid ("IFB") for Project 20.04 – Main Office Building Roof Replacement was issued on April 29, 2024. The necessary legal notice was published in the <u>Plain Dealer</u> and <u>Call & Post</u> newspapers. The Invitation for Bid was also published on the RTA web site.

The Invitation for Bid ("IFB") was accessed and/or downloaded from the web site by nine (9) interested parties. Four (4) bids were received and opened on May 30, 2024, as follows:

A.W. Farrell & Son, Inc.	\$1,192,000.00
Architectural Siding, Trim and Roofing, Inc.	\$1,297,845.00

The Basis of Award is the lowest responsive bid from a responsible bidder for the Total Base Bid price. Warren Roofing & Insulating, LLC. was determined to be a responsive bidder.

#### RECOMMENDATION:

The Office of Business Development has set a 14% DBE participation goal for this project. Warren Roofing & Insulating, LLC. intends on using All Contractors Supply to meet this goal.

Warren Roofing & Insulating, LLC. has successfully completed projects for NASA, Ford Motor Company, Progressive Field, Chardon Local Schools, and the City of Cleveland, among others.

A resolution will request authorization to issue a contract to Warren Roofing & Insulating, LLC. for the replacement of the roof of the Main Office Building in an amount not to exceed \$940,000.00. This bid is 34.09% below the Engineer's Estimate of \$1,426,274.35.

## SUMMARY OF AWARD Main Office Building HVAC Replacement

## PROJECT OVERVIEW:

The Greater Cleveland Regional Transit Authority (GCRTA) has the need to replace the HVAC of the Main Office Building. The work to be performed under this contract includes, but is not limited to, removal of five existing HVAC units and replacement with similarly rated units, completing any necessary curb or ductwork modifications, among other tasks.

## PROCUREMENT OVERVIEW:

The Invitation for Bid ("IFB") for Project 19.14 – Main Office Building HVAC Replacement was issued on April 29, 2024. The necessary legal notice was published in the <u>Plain Dealer</u> and <u>Call & Post</u> newspapers. The Invitation for Bid was also published on the RTA web site.

The Invitation for Bid ("IFB") was accessed and/or downloaded from the web site by ten (10) interested parties. Three (3) bids were received and opened on May 30, 2024, as follows:

CRS Metalworx, Inc.	\$1,575,000.00
Trane US, Inc.	\$1,635,500.00
Building Integrated Services	\$2,074,611.00

The Basis of Award is the lowest responsive bid from a responsible bidder for the Total Base Bid price. CRS Metalworx, Inc. was determined to be a responsive bidder.

#### RECOMMENDATION:

The Office of Business Development has set a 19% DBE participation goal for this project. CRS Metalworx, Inc. completed the good faith effort documentation to support a DBE participation of 0%. This was reviewed and approved by the Office of Business Development.

CRS Metalworx, Inc. has successfully completed projects for the City of Cleveland, City of North Olmsted, City of Westlake, Akron Children's Hospital, and the City of Akron, among others.

A resolution will request authorization to issue a contract to CRS Metalworx, Inc. for the replacement of the HVAC of the Main Office Building in an amount not to exceed \$1,575,000.00. This bid is 7.49% below the Engineer's Estimate of \$1,702,500.00.

Proposed Change Order to Contract No. 2022-122 with Bison Rail Systems for

Project 12D – Trunk Line Signal System

At the July 9, 2024 Operational Planning & Infrastructure Committee meeting, staff will present a proposed change order to Contract No. 2022-122 with Bison Rail Systems ("Bison") to provide a new modern signaling system on the light rail trunk line from East 79th Street Station to Shaker Square. The superior solution offered by Bison will substitute PSO-4000 audio frequency overlay track circuits for 60Hz vane power frequency track circuits, providing broken rail detection. The change order will also amend the dates for the performance of the contractor's services and compensate the contractor for the extended schedule.

Within this change order, staff will also request re-instatement of the General Manager's change order authority, as authorized under the Delegation of Authority policy contained in Chapter 470 of the Code Book. We will be requesting that the Operational Planning & Infrastructure Committee recommend this request be moved for approval to the July 30, 2024 meeting of the Board of Trustees.

Proposed FY 2025 Tax Budget

On Tuesday, July 9, 2024, staff will present the Proposed Fiscal Year ("FY") 2025 Tax Budget. which will include the Fund Statements with the explanations and financial assumptions used in the development of the Tax Budget.

The FY 2025 Tax Budget is the first of two legislative steps to establish the financial plan for the upcoming fiscal year. To provide an opportunity for the public to comment, a public hearing will also be held on July 9, 2024, in the Board Room of the Greater Cleveland Regional Transit Authority.

The development of a tax budget requires an early review and analysis of the Authority's projected revenues and expenditures. It provides the initial framework for the next budget cycle and begins the process for formally adopting the FY 2025 budget appropriations. The Tax Budget defines anticipated expenses in very broad terms, but its primary emphasis is on expected revenues.

The Operational Planning and Infrastructure Committee will be requested to recommend the FY 2025 Tax Budget to the full Board for discussion and approval at the July 30, 2024, RTA Board Meeting. Once the Tax Budget is adopted, it will be filed with the Cuyahoga County Budget Commission.
