# SUMMARY OF AWARD Brookpark Yard Tracks Improvements

### PROJECT OVERVIEW:

The Greater Cleveland Regional Transit Authority (GCRTA) has the need to complete various improvements to the Brookpark yard tracks to receive the new railcars. This work includes, but is not limited to, track work, track surfacing and lining, installation of new rail, destressing rail, installation of insulated joints, and welding activities.

### **PROCUREMENT OVERVIEW:**

The Invitation for Bid ("IFB") for Project 66C – Brookpark Yard Tracks Improvements was issued on November 18, 2024. The necessary legal notice was published in the <u>Plain Dealer</u> and <u>Call</u> & Post newspapers. The IFB was also published on the RTA web site.

The IFB was accessed and/or downloaded from the web site by twelve (12) interested parties. Two (2) bids were received and opened on December 19, 2024, as follows:

The Basis of Award is the lowest responsive bid from a responsible bidder for the Total Base Bid price. RailWorks Track Services, LLC was determined to be a responsive bidder.

### RECOMMENDATION:

The Office of Business Development has set a 17% DBE participation goal for this project. This goal will be achieved using Cook Paving and Construction Co., Inc. and William G. Moore & Son, Inc. of Delaware. This was reviewed and approved by the Office of Business Development.

RailWorks Track Services, LLC has successfully completed projects for GCRTA, Amtrak, Michigan Department of Transportation, and MTA Maryland, among others.

A resolution will request authorization to issue a contract to RailWorks Track Services, LLC for the Brookpark Yard Tracks Improvements in an amount not to exceed \$2,589,826.00. This bid is 41.14% below the Engineer's Estimate of \$4,400,000.00.

### PROJECT OVERVIEW:

The Greater Cleveland Regional Transit Authority (GCRTA) is required to complete various improvements to the Brookpark Rail Shop to receive the new railcars. This work includes, but is not limited to, existing trolley crane system upgrades, modifications to the building for entry and occupancy of the facility via rail, concrete slab changes, mezzanine updates, electrical system modifications, among other tasks.

### **PROCUREMENT OVERVIEW:**

The Invitation for Bid ("IFB") for Project 66C2 – Brookpark Rail Shop Modifications was issued on December 9, 2024. The necessary legal notice was published in the <u>Plain Dealer</u> and <u>Call & Post</u> newspapers. The IFB was also published on the RTA web site.

## SUMMARY OF PROPOSED AWARD HASTUS Software Maintenance and Support

### PROJECT OVERVIEW:

The Greater Cleveland Regional Transit Authority has an ongoing need for annual software maintenance and support for its bid dispatch and scheduling system, branded as HASTUS. HASTUS is a product of GIRO, Inc. The HASTUS system provides scheduling, run-cutting, performance management and dispatching for the Authority's bus and rail operations. HASTUS is also the catalyst for operator payroll. Because of the critical nature of this system, it must be able to function without significant downtime or delays. This maintenance agreement will ensure timely expert support to resolve any delay-threatening problems.

### PROCUREMENT OVERVIEW:

The Authority has had the need for an ongoing maintenance and support agreement with GIRO, Inc. for its bid dispatch and scheduling software, HASTUS. The HASTUS software is proprietary to GIRO, Inc. Any training, upgrades, modifications, maintenance & support and/or development to the software must be provided by GIRO, Inc. A maintenance and support agreement must be maintained with GIRO, Inc., the original provider, to ensure the software is properly supported. Due to these reasons, this project is deemed a sole source procurement and is exempt from competitive bidding as authorized under Section 306.43(H)(3) of the Ohio Revised Code.

The Procurement Department requested a proposal from GIRO, Inc. on November 21, 2024. A proposal was received on December 3, 2024. The proposal was reviewed by representatives from the Information Technology and Procurement Departments, and is deemed to be advantageous, fair, and reasonable to the Authority.

Landscape Maintenance and Parking Lot Snow Removal for One Year (Shaker

Hts. Maintenance Agreement)

At the February 4, 2025 Organizational, Services & Performance Monitoring Committee meeting, staff will present a resolution authorizing an agreement with the City of Shaker Hts. for landscape maintenance and parking lot snow removal for a period of one year beginning January 1, 2025 in an amount not to exceed \$320,064.55.

The initial Interagency Agreement was entered into as part of the Mass Transit System Transfer Agreement by which the Authority acquired the Shaker Heights Rapid Transit System, including the rights-of-way. In a series of subsequent agreements, the City agreed to perform landscaping and snow removal services, and the Authority agreed to compensate the City for its labor and material costs pursuant to a fixed schedule of services.

The cost for the scheduled regular services from January 1, 2025 through December 31, 2025 is an amount not to exceed \$282,169.68, to be paid in equal monthly installments upon presentation of invoices from the City. The cost of regularly scheduled maintenance will increase by \$10,852.68 over the 2024 expense.

In addition, there may be additional services for planting replacement landscaping at several locations that will be impacted by the Authority's Shaker Boulevard Shelter project. If such services are rendered in 2025, the City will render a separate invoice for such services in an amount not to exceed \$37,894.87, which is the agreed compensation for the services and includes a contingency amount for the City's new labor rates that will take effect in 2025.

The total compensation under this agreement is an amount not to exceed \$320,064.55.

### PROJECT OVERVIEW:

Procurement of ultra low sulfur diesel fuel is used to fuel the Authority's revenue, non-revenue vehicles including RTA service/maintenance equipment. We procure approximately 1,000,000 gallons of ultra low sulfur diesel fuel per year.

For evaluation purposes of this bid, the bid price reflects the cost of the Oil Price Information Service ("OPIS") index plus bidders cost differential. The cost differential shall include the bidder's delivery and profit on a per gallon basis. Taxes (except as noted) are not included in the bid price.

### PROCUREMENT OVERVIEW:

The Authority plans to price the delivery of its ultra low sulfur diesel fuel requirements on the OPIS index average daily rate on the date of delivery. The Invitation for Bid ("IFB") for the Procurement of Ultra Low Sulfur Diesel Fuel for a Period of Three Years was issued on December 15, 2025. The necessary legal notice was published in the Plain Dealer and Call & Post newspapers. The IFB was also published on the RTA web site.

Approval of the 2026-2033 Petition for Services for the Downtown Cleveland

Improvement District

At the February 25, 2025 meeting of the Board of Trustees, staff will request approval to renew GCRTA's participation in the Downtown Cleveland Improvement District ("DCID"), a special improvement district in the City of Cleveland. Pursuant to R.C. 1710.02, property owners in a geographic location may create a special improvement district to assess themselves the cost of providing additional area-wide services.

GCRTA joined the DCID on June 21, 2005, by Resolution No. 2005-082. The Board of Trustees approved renewed participation on June 17, 2009 in Resolution No. 2009-101 and on February 17, 2015 in Resolution No. 2015-17.

Currently, the Downtown Cleveland Improvement Corporation is proposing a new assessment and geographic area for the DCID. As a property owner of 17 parcels within the DCID, GCRTA has been asked to execute the *Petition to Approve the Adjustment of the Downtown Cleveland Improvement District and to Approve the Comprehensive Services Plan of the District ("Petition") for the years 2026-2032.* The assessment amount for the years 2026-2032 will not exceed \$302,576.00.

GCRTA, its employees, and customers benefit from continued participation in the DCID through the DCID Safety Ambassador program, additional security, and cleanliness efforts paid for by the assessments collected from GCRTA and other property owners. The DCID also has economic development programs for retail corridor development, office building outreach, and business technical assistance.
